## A BILL FOR AN ACT

RELATING TO EARLY LEARNING ACCREDITATION.

#### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. The legislature finds that preschool and other 2 early learning programs are critical to the development of young 3 children in gaining essential skills, being prepared for school, 4 and charting a course for lifelong success. The legislature 5 also finds that the preschool open doors program established 6 within the department of human services' child care assistance 7 program aims to provide low- and moderate-income families with 8 the opportunity to send their children to preschool by providing 9 eligible families with subsidies to help pay preschool tuition.

10 The legislature further finds that accreditation from 11 national early learning accrediting organizations is one 12 indicator that a child care program is providing a level of care 13 that meets high-quality standards set by these organizations. 14 The State's preschool open doors program therefore requires 15 service providers who wish to participate in the preschool open 16 doors program to obtain accreditation from national early 17 learning accrediting organizations, and service providers who

1 have not done so by July 1, 2022, must start the accreditation 2 process no later than July 1, 2024, and be accredited by July 1, 2029. The department of human services is required to provide 3 4 operational and financial support to assist these service 5 providers to obtain accreditation and may contract with a 6 private entity for that purpose. The purpose of this Act is to: 7 8 (1) Establish within the department of human services' 9 child care subsidy program office, a child care 10 accreditation program to support licensed or 11 registered child care providers to obtain 12 accreditation from a national early learning 13 accrediting organization or an accrediting 14 organization approved by the director of human 15 services; 16 (2) Extend the deadlines by which unaccredited service 17 providers of the preschool open doors program must 18 commence the accreditation process and obtain -19 accreditation; 20 (3) Appropriate funds for the establishment, 21 implementation, and administration of the child care

1 (1)Expenses to retain technical assistance for the 2 accreditation process; and 3 (2) Incidental expenses to obtain furniture and equipment 4 and to make minor renovations to the child care 5 provider's facilities required by the national early 6 learning accrediting organization to issue the 7 accreditation. 8 (C) The department of human services may contract with a 9 private entity in accordance with chapter 103D, Hawaii Revised 10 Statutes, to administer the program. 11 (d) The department shall adopt rules in accordance with 12 chapter 91, Hawaii Revised Statutes, to carry out the purpose of 13 this Act, including rules on the standards, policies, and 14 procedures for the administration of the child care 15 accreditation program. 16 (e) The department of human services shall submit a report 17 regarding the implementation and performance of the child care 18 accreditation program, including any proposed legislation, to 19 the legislature no later than twenty days prior to the convening 20 of each regular session. There is appropriated out of the general 4 5 revenues of the State of Hawaii the sum of \$ or so 6 much thereof as may be necessary for fiscal year 2023-2024 and 7 the same sum or so much thereof as may be necessary for fiscal 8 year 2024-2025 for the establishment, implementation, and 9 administration of the child care accreditation program 10 established pursuant to section 2 of this Act, including paying 11 the cost of annual accreditation fees incurred by eligible child 12 care providers participating in the preschool open doors 13 program. 14 The sums appropriated shall be expended by the department 15 of human services for the purposes of this Act and may be used 16 for necessary administrative and other costs of implementation, 17 including funding for one full time equivalent (1.0 FTE) 18 position. 19 SECTION 5. Statutory material to be repealed is bracketed 12 and stricken. New statutory material is underscored. 13 SECTION 7. This Act shall take effect on December 31, 2050. 14
