### A BILL FOR AN ACT

RELATING TO LEAF BLOWERS.

### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

SECTION 1. Section 342F-30.8, Hawaii Revised Statutes, is
amended to read as follows:

3 "[+] §342F-30.8[+] Leaf blowers; restrictions. (a) In any 4 urban land use district, as designated pursuant to section 5 205-2, it shall be unlawful for any person to operate a leaf blower within a residential zone or within one hundred feet of a 6 7 residential zone in the State, except between the hours of 8 8:00 a.m. and 6:00 p.m. on any day except Sunday or a state or 9 federal holiday, and between the hours of 9:00 a.m. and 10 6:00 p.m. on Sunday or any state or federal holiday [-]; provided 11 that government entities, and agents acting on behalf of government entities, may use leaf blowers during the prohibited 12 13 hours in the case of an emergency as defined in section 127A-2. 14 (b) Violators shall be fined \$50 for the first violation, 15 \$100 for the second violation, \$200 for the third violation, and 16 \$500 for each subsequent violation.

#### Report Title:
