A BILL FOR AN ACT

RELATING TO SUSTAINABLE FOOD SYSTEMS.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The legislature finds that a sustainable food
- 2 system is one in which producers, retailers, members of the
- 3 community, non-governmental organizations, and government
- 4 agencies partner to create a vibrant and resilient local food
- 5 economy that enhances and sustains the environmental, economic,
- 6 and social health of the community.
- 7 The legislature further finds that developing a more
- 8 sustainable food system in Hawaii represents an opportunity to
- 9 create a new food economy that integrates the objectives of
- 10 "green" job creation, sustainable economic development, land
- 11 stewardship, food security, environmental protection, and
- 12 climate change resiliency with community health and well-being.
- 13 Therefore, the purpose of this Act is to establish within
- 14 the department of agriculture a sustainable food systems working
- 15 group to develop an interagency food systems plan.
- 16 SECTION 2. (a) There is established within the department
- 17 of agriculture the sustainable food systems working group. The

- 1 working group shall identify a governance structure and
- 2 implementation plan for an interagency food systems plan linked
- 3 to the United Nations Sustainable Development Goals for a more
- 4 sustainable, resilient local food economy that enhances and
- 5 sustains the environmental, economic, and social health of the
- 6 community.
- 7 (b) The sustainable food systems working group shall be
- 8 composed of the following members:
- 9 (1) One member of the house of representatives, to be
- selected by the speaker of the house of
- 11 representatives;
- 12 (2) One member of the senate, to be selected by the
- president of the senate;
- 14 (3) A representative of the Hawaii tourism authority, to
- be selected by the president and chief executive
- 17 (4) Two representatives of the university of Hawaii system
- who have experience in food systems, to be selected by
- 19 the dean of the college of tropical agriculture and
- 20 human resources;

3	(10)	A representative of the Hawaii Farm Bureau, who shall
4		be invited to participate, to be selected by the
5		president of the Hawaii Farm Bureau;
6	(11)	A representative of the Hawaii Foodbank, who shall be
7		invited to participate, to be selected by the
8		president and chief executive officer of the Hawaii
9		Foodbank;
10	(12)	A representative of the agricultural sector, to be
11		selected by the chairperson of the board of
12		agriculture;
13	(13)	Four representatives of the agricultural sector, each
14		of whom respectively represent the counties of Hawaii,
15		Kauai, Maui, and the city and county of Honolulu, to
16		be selected by the respective mayor of each county;
17	(14)	A representative of the farm-to-school community in
18		Hawaii, to be selected by the chairperson of the board
19		of agriculture;

1 selected by the president of the Hawaii Cattlemen's 2 Council, Inc. 3 (c) The chairperson of the board of agriculture shall 4 serve as chair of the sustainable food systems working group. 5 (d) The interagency food systems plan shall address the 6 following: 7 (1)Food as a human right and healthy food for all 8 persons; 9 (2) Social equity and food justice; 10 (3) Food system resilience; 11 (4)Agriculture and food system sustainability; 12 (5) Food at the center of a circular economy; 13 Sustainable education, workforce development, and fair (6) 14 labor; and 15 (7) Good food governance. (e) The sustainable food systems working group shall 16 17 submit its interagency food systems plan and any recommendations 18 for implementation of the plan, including any proposed 19 legislation, to the legislature no later than twenty days prior 20 to the convening of the regular session of 2025.

- 1 (f) The department of agriculture shall provide any
- 2 necessary staff support, including for the preparation of the
- 3 plan identified in subsection (a), to the sustainable food
- 4 systems working group.
- 5 (g) The sustainable food systems working group shall be
- 6 dissolved on June 30, 2025.
- 7 SECTION 3. There is appropriated out of the general
- 8 revenues of the State of Hawaii the sum of \$ or so
- 9 much thereof as may be necessary for fiscal year 2023-2024 and
- 10 the same sum or so much thereof as may be necessary for fiscal
- 11 year 2024-2025 for the purpose of establishing the sustainable
- 12 food systems working group and implementing section 2 of this
- 13 Act, including coordinating stakeholder meetings; managing
- 14 public meetings and website data in accordance with chapter 92,
- 15 Hawaii Revised Statutes; writing and printing the interagency
- 16 food systems plan; and potentially obtaining services for a fee.
- 17 The sums appropriated shall be expended by the department
- 18 of agriculture for the purposes of this Act.
- 19 SECTION 4. There is appropriated out of the general
- 20 revenues of the State of Hawaii the sum of \$ or so
- 21 much thereof as may be necessary for fiscal year 2023-2024 and

- 1 the same sum or so much thereof as may be necessary for fiscal
- 2 year 2024-2025 for full-time equivalent
- 3 (FTE) sustainability specialist position in the
- 4 department of agriculture.
- 5 The sums appropriated shall be expended by the department
- 6 of agriculture for the purposes of this Act.
- 7 SECTION 5. This Act shall take effect on July 1, 2050.

Establishes the sustainable food systems working group within the Department of Agriculture. Requires the working group to submit an interagency food systems plan, any recommendations for implementing the plan, and any proposed legislation to the Legislature. Appropriates funds to establish the working group and develop the plan and for an unspecified number of sustainability specialist positions within the Department of Agriculture. Effective 7/1/2050.
