A BILL FOR AN ACT

RELATING TO ENVIRONMENTAL PROTECTION.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The legislature finds that perfluoroalkyl and
- 2 polyfluoroalkyl substances (PFAS) are persistent, toxic
- 3 substances that can contaminate drinking water, bioaccumulate in
- 4 fish and wildlife, and have multiple adverse health effects on
- 5 humans. PFAS are utilized in a broad range of products,
- 6 including clothing, textiles, food packaging, and cosmetic
- 7 products, such as lotions, nail polish, shaving cream, and
- 8 mascara.
- 9 The legislature further finds that PFAS are often called
- 10 "forever chemicals" due to the fact that they do not naturally
- 11 break down in the environment and can continue to pollute the
- 12 environment for thousands of years. PFAS can enter the human
- 13 body when consumed, applied directly on skin, and after eating
- 14 food packaged in materials that contain PFAS. In 2022, the
- 15 legislature passed Act 152, Session Laws of Hawaii 2022, which
- 16 prohibits, by the end of 2024, PFAS in certain types of food
- 17 packaging and firefighting foam. However, in light of the



- 1 recent spill of approximately one thousand three hundred gallons
- 2 of toxic PFAS-containing firefighting foam at Red Hill in
- 3 November 2022 and the discovery of another firefighting foam
- 4 spill in September 2020, it is evident that further action is
- 5 needed.
- 6 As an island state, when these forever chemicals are
- 7 brought here, they never leave. Instead, they make their way
- 8 into residents' bodies and the State's wastewater, landfills,
- 9 and eventually groundwater and drinking water supply. Hawaii
- 10 can no longer afford to import toxic substances that contaminate
- 11 the State's finite resources and risk residents' health.
- 12 Accordingly, the purpose of this Act is to prohibit the
- 13 manufacture, sale, offer for sale, distribution for sale, and
- 14 distribution for use of any food packaging, food service ware,
- 15 cosmetic, or personal care product that contains intentionally
- 16 added PFAS.
- 17 SECTION 2. Chapter 321, Hawaii Revised Statutes, is
- 18 amended by adding a new section to part XLVII to be
- 19 appropriately designated and to read as follows:
- 20 "S321- Food packaging, food service ware, cosmetics,
- 21 personal care products; prohibited items. (a) Beginning



1	December	31, 2026, it shall be unlawful to manufacture, sell,
2	offer for	sale, distribute for sale, or distribute for use in
3	the State	any food packaging, food service ware, cosmetic, or
4	personal	care product that contains intentionally added PFAS;
5	provided	that this section shall not apply to:
6	(1)	Hydrofluoroolefins used as propellents in cosmetics;
7		and
8	(2)	A product that is regulated as a drug, medical device,
9		or dietary supplement by the United States Food and
10		Drug Administration under the Federal Food, Drug, and
11		Cosmetic Act (21 U.S.C. 321 et seq.); title 21 Code of
12		Federal Regulations section 3.2(e); or the Dietary
13		Supplement Health and Education Act of 1994.
14	(b)	For the purposes of this section:
15	"Cosmetic" has the same meaning as in section 321-30.4.	
16	"Food service ware" means all containers, bowls, bowl lids,	
17	clamshells, plates, trays, cups, cup lids, straws, forks,	
18	spoons, knives, napkins, utensils, chopsticks, cup sleeves,	
19	condiment packets and saucers, stirrers, splash sticks, cocktail	
20	sticks, t	oothpicks, and other like items that are designed for a
21	single us	e for or alongside prepared foods, including but not

1 limited to service ware for takeout foods or leftovers from 2 partially consumed meals prepared by food vendors. 3 "Intentionally added PFAS" means either of the following: 4 (1) PFAS chemicals that a manufacturer has intentionally 5 added to a product and that have a functional or 6 technical effect on the product; or 7 (2) PFAS chemicals that are intentional breakdown products 8 of an added chemical. 9 "Personal care product" has the same meaning as in section 10 321-30.5." 11 SECTION 3. Section 321-602, Hawaii Revised Statutes, is 12 repealed. 13 ["[\$321-602] Food packaging; prohibited items. (a) 14 Beginning December 31, 2024, it shall be unlawful to 15 manufacture, sell, offer for sale, distribute for sale, or 16 distribute for use in the State any food packaging specified in 17 subsection (b) to which PFAS chemicals have been intentionally 18 introduced in any amount. 19 (b) The prohibition under this section shall apply to 20 wraps and liners, plates, food boats, and pizza boxes."]
