A BILL FOR AN ACT

RELATING TO THE DEPARTMENT OF HAWAIIAN HOME LANDS.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1	SECTION 1. The legislature finds that according to a
2	survey conducted by the department of Hawaiian home lands in
3	2022, more than twenty-eight thousand native Hawaiian
4	beneficiaries are currently on the homestead lease waiting list
5	The legislature further finds that when beneficiaries on the
6	homestead lease waiting list pass away prior to receiving a
7	lease award, the beneficiary also loses the ability to have
8	their heirs succeed to a lease. Accordingly, the purpose of
9	this Act is to allow the department of Hawaiian home lands to:
10	(1) Grant lease awards to elderly or terminally ill
11	beneficiaries on the waiting list and provide those
12	beneficiaries with an option to designate a qualified
13	successor; and
14	(2) Grant posthumous lease awards directly to qualified
15	successors of elderly or terminally ill beneficiaries
16	who were on the waiting list; provided that the

- 1 successors file a claim for a lease award within four
- 2 years of the effective date of this Act.
- 3 SECTION 2. (a) The department of Hawaiian home lands may
- 4 administer a lease award program for beneficiaries on the
- 5 waiting list who are:
- **6** (1) Sixty years or older; or
- 7 (2) Terminally ill;
- 8 provided that the beneficiary on the waiting list may designate
- 9 a successor upon receipt of the lease award.
- 10 (b) Any qualified successor of a beneficiary who passed
- 11 away while on the waiting list shall have four years from the
- 12 effective date of this Act to file a claim for a lease award in
- 13 place of the named deceased beneficiary.
- 14 (c) The department of Hawaiian home lands shall adopt
- 15 rules pursuant to chapter 91, Hawaii Revised Statutes, to
- 16 administer this Act within one year of the effective date of
- 17 this Act.
- 18 SECTION 3. This Act shall take effect upon its approval.

Beneficiaries; Lease Award; Successors; Successorship Claims; Department of Hawaiian Home Lands

Description:

Authorizes beneficiaries on the Department of Hawaiian Home Lands waiting list, who are sixty years or older or terminally ill, to receive a lease award and to designate a qualified successor. Authorizes qualified successors of beneficiaries on the waiting list who died before receiving a lease to file a claim for a lease award within four years of the effective date. Requires the Department of Hawaiian Home Lands to adopt rules by a certain date. (SD1)
