A BILL FOR AN ACT

RELATING TO COFFEE PEST CONTROL.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. The legislature finds that coffee is one of the 2 largest agricultural crops in the State and is a highly valued commodity in Hawai`i's economy. In recent years, the coffee 3 berry borer, a small beetle, has infested coffee crops in the 4 5 Kona and Ka`ū regions of Hawai`i island, and more recently has 6 been detected on O`ahu, Maui, Kaua`i, and Lana`i. In 2020, 7 coffee leaf rust, caused by a fungal pathogen, was discovered 8 for the first time in the State on Maui and Hawai`i island. 9 These two pests threaten the viability of the State's entire 10 coffee industry. Efforts to control coffee berry borer and 11 coffee leaf rust, including the use of United States Food and 12 Drug Administration-approved pesticides, are critical to the 13 local coffee industry, and it is incumbent upon the State to 14 continue to support these efforts.

15 The legislature further finds that in response to these 16 threats to the industry, the coffee berry borer pesticide 17 subsidy program was established by Act 105, Session Laws of

1 Hawaii 2014 (Act 105), to assist Hawai'i coffee farmers with 2 offsetting the cost of pesticides containing the fungus 3 Beauveria bassiana, which is known to control coffee berry 4 borer. Due to a longer-than-anticipated implementation of Act 5 105, in 2017, the legislature extended the pesticide subsidy 6 program from its original sunset date of June 30, 2019, to 7 June 30, 2021, via Act 65, Session Laws of Hawaii 2017 (Act 65). 8 After continued programmatic success and the initial discovery 9 of coffee leaf rust in the islands, in 2021, the legislature 10 extended the pesticide subsidy program for another two years, 11 adding a subsidy for coffee leaf rust pesticides.

12 As of December 9, 2022, the department of agriculture has 13 received nine hundred eighty receipts for reimbursement under 14 the coffee berry borer pesticide subsidy program, expending a 15 total of \$812,319.99 for the mitigation of coffee berry borer 16 and coffee leaf rust throughout the State. The legislature 17 finds that, as illustrated by program demand, coffee berry borer 18 and coffee leaf rust continue to pose a severe threat to the 19 State's coffee industry, and it is incumbent upon the State to 20 continue supporting farmers' mitigative efforts, including

1 through reducing the financial burden of having to purchase 2 certain pesticides at market value. 3 Accordingly, the purpose of this Act is to: 4 Extend the pesticide subsidy program to June 30, 2025; (1) 5 (2) Extend the pesticide subsidy manager position, 6 including the position's exemptions from civil service 7 and collective bargaining laws, until June 30, 2026; 8 and 9 (3) Appropriate funds for the program and program manager 10 position. 11 SECTION 2. Act 105, Session Laws of Hawaii 2014, as 12 amended by section 1 of Act 152, Session Laws of Hawaii 2015, as 13 amended by section 2 of Act 65, Session Laws of Hawaii 2017, as 14 amended by section 2 of Act 32, Session Laws of Hawaii 2018, as 15 amended by section 43 of Act 111, Session Laws of Hawaii 2019, as amended by section 2 of Act 138, Session Laws of Hawaii 2021, 16 17 is amended as follows: 18 1. The department shall grant subsidies to coffee growers to assist
 the coffee growers in offsetting the costs of purchasing any
 pesticide that is listed by the department pursuant to
 subsection (f)."

5 2. By amending subsections (c) through (e) of section 3 to6 read:

7 "(c) Documentation of pesticide costs, as requested by the 8 department, shall be filed for pesticides purchased within the 9 immediately preceding fiscal year of filing and shall be 10 effective for pesticide costs incurred after June 30, 2014, and 11 before July 1, [2023.] 2025.

12 (d) Funds shall be disbursed upon approval on an annual
13 basis by the department to the coffee grower for up to
14 [seventy-five]:

15 (1) Seventy-five per cent of the costs incurred for the 16 purchase of the pesticide before July 1, 2016[, and 17 for up to fifty];

18 (2) Fifty per cent of the costs incurred for the purchase
 19 of the pesticide for the period beginning after
 20 June 30, 2016, and before July 1, 2023 [-]; and

1	(3) Seventy-five per cent of the costs incurred for the
2	purchase of the pesticide for the period beginning
3	July 1, 2023, through June 30, 2025.
4	(e) The department shall aggregate the total subsidy
5	applications pursuant to this section and divide and distribute
6	the available subsidy funds on a pro rata basis; provided that
7	no single coffee grower shall receive subsidies that are more
8	than \$600 per year for coffee berry borer control and more than
9	\$600 per year for coffee leaf rust control per acre of land in
10	coffee production; provided further that no single coffee grower
11	shall receive subsidies that are more than \$9,000 per year;
12	provided further that no single coffee grower shall receive
13	subsidies that total more than \$6,000 per year for the period
14	after June 30, 2018, and before July 1, 2021; provided further
15	that no single coffee grower shall receive subsidies that total
16	more than \$12,000 per year for the period after June 30, 2021,
17	and before July 1, [2023.] <u>2025.</u> "
18	3. By amending subsections (g) and (h) of section 3 to

20 "(g) There is established within the department a
21 pesticide subsidy program manager position, which shall be a

1 full-time, temporary position exempt from chapters 76 and 89, 2 Hawaii Revised Statutes. The pesticide subsidy program manager 3 shall possess a requisite level of knowledge and expertise in 4 the area of program management necessary to carry out the duties 5 of the position. The pesticide subsidy program manager shall: 6 (1) Facilitate the efficient division and distribution of 7 available subsidy funds; and 8 (2) Manage the day-to-day coordination for the pesticide 9 subsidy program. 10 The pesticide subsidy program manager shall receive a 11 salary of not more than \$50,000 per year. The pesticide subsidy 12 program manager position, including the position's exemption 13 from chapters 76 and 89, Hawaii Revised Statutes, shall expire 14 on June 30, [2024.] 2026. 15 (h) Not later than twenty days prior to the convening of 16 the regular session of [2023,] 2025, the department shall submit

17 a report of its findings and recommendations, including any 18 proposed legislation, to the legislature on the results of the 19 subsidy program and whether the program should be allowed to 20 expire or be extended, and if extended, with or without 21 modification."

thereof as may be necessary for fiscal year 2024-2025 for the
 operation and implementation of the pesticide subsidy program.
 The sums appropriated shall be expended by the department
 of agriculture for the purposes of this Act.

5 SECTION 5 Statutory material to be repealed is bracketed
6 and stricken. New statutory material is underscored.

7 SECTION 6. This Act shall take effect on July 1, 2050;
8 provided that sections 3 and 4 of this Act shall take effect on
9 July 1, 2050.

Description:

Extends the sunset date for the coffee berry borer and coffee leaf rust pesticide subsidy program to 6/30/2025 and the program manager position, including the position's civil service and collective bargaining laws exemption, to 6/30/2026. Requires the Department of Agriculture to report to the Legislature. Appropriates funds for the operation and implementation of the pesticide subsidy program. Effective 7/1/2050, provided that the appropriation shall take effect on 7/1/2050. (SD1)
