RELATING TO MOTOR VEHICLE REGISTRATION.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1	SECTION 1. Section 286-41, Hawaii Revised Statutes, is

13		tempo	orarily moving in or between terminals at:		
14		(A)	Sand Island and along Sand Island Parkway and		
15			Sand Island Access Road;		
16		(B)	Kalanianaole Avenue between Kuhio Street and		
17			Kahanu Street, abutting Hilo Harbor;		

1	(C)	Kawaihae-Mahukona Road abutting Kawaihae Harbor;
2	(D)	East Kaahumanu Avenue between Hobron Avenue and
3		Kane Street, abutting Kahului Harbor; [and]
4	(E)	Waipaa Road abutting Nawiliwili Harbor[+];
5	<u>(F)</u>	Nimitz Highway, from 8:30 a.m. to 3:00 p.m., and
6		from 6:30 p.m. to 5:30 a.m.;
7	(G)	Sand Island Access Road and Forrest Avenue,
8		including all roadways abutting pier accessways;
9		provided that vehicles abide by the speed limit
10		and keep up with the flow of traffic;
11	<u>(H)</u>	Auiki Street, abutting Kapalama Container
12		<pre>Terminal;</pre>
13	<u>(I)</u>	Malakole Street, abutting Barbers Point; and
14	(<u>U</u>)	Hanua Street, abutting Barbers Point; provided
15		that an escort vehicle is present."
16	SECTION 2	. Statutory material to be repealed is bracketed
17	and stricken.	New statutory material is underscored.
18	SECTION 3	. This Act shall take effect on July 1, 2023.

Motor Vehicle Registration; Flatbed Trucks; Exemption

Description:

Provides an exemption for flatbed trucks from registration renewals and initial registrations of motor carrier vehicles when used as marine terminal equipment temporarily moving in or between certain terminals. Adds new terminal locales and roadways to be covered under the exemption. (SD1)
