A BILL FOR AN ACT

RELATING TO THE HAWAII STATE HEALTH INSURANCE ASSISTANCE PROGRAM.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The legislature finds that medicare is
- 2 essential to providing health care coverage for older adults and
- 3 persons having disabilities in the State. However, the rules
- 4 and procedures for medicare eligibility and enrollment are
- 5 complex and difficult to navigate, especially for kupuna. The
- 6 legislature further finds that Hawaii's medicare population has
- 7 increased one hundred twenty per cent over the span of thirty
- 8 years, from 133,439 persons in 1992 to 295,405 in 2022.
- 9 According to World Population Review, an independent
- 10 organization without political affiliations, Hawaii ranks first
- 11 in the nation in terms of longevity, with residents living 81.3
- 12 years on average, and the cost of living in Hawaii is almost
- 13 double that of the national average, at 193.3 per cent. In
- 14 2022, total medical and prescription drug spending rose to
- 15 \$157,480,248. According to a Financial Health Network and
- 16 Hawaii Community Foundation report, seventy-three per cent of

- 1 beneficiaries report dipping into savings and forty-seven per
- 2 cent report relying on family and friends for financial support.
- 3 Approximately four per cent of the State is uninsured, and about
- 4 eleven per cent lives in poverty. Without insurance, unexpected
- 5 medical costs or a catastrophic illness could result in the loss
- 6 of one's home and assets. A lack of health care coverage will
- 7 lower health outcomes and increase health care costs, poverty
- 8 rates, and the number of individuals who qualify for the already
- 9 overburdened medicaid program.
- 10 The legislature further finds that the Hawaii state health
- 11 insurance assistance program was established within the
- 12 executive office on aging in 1992 with two temporary staff
- 13 members. The program's purpose is to assist and educate
- 14 medicare beneficiaries to:
- 15 (1) Make informed health insurance choices based on the
- beneficiary's needs and budget;
- 17 (2) Enroll in medicare as soon as first eligible to avoid
- 18 lifetime late enrollment penalties;
- 19 (3) Access wellness and preventive services to improve
- health outcomes, lower health care costs, and promote
- aging in place; and

- (4) Enroll in low-income subsidy programs, including
 medicaid, to reduce out-of-pocket costs.
- 3 The Hawaii state health insurance assistance program
- 4 collaborates with county agencies on aging to conduct statewide
- 5 outreach at health fairs, enrollment events, senior centers, and
- 6 community organizations and through presentations to employers
- 7 to promote the program's free, local, unbiased, and confidential
- 8 services. Hawaii's state health insurance assistance program
- 9 currently serves over eight thousand eight hundred individuals,
- 10 approximately three per cent of Hawaii's medicare population.
- 11 The Administration for Community Living considers eight per cent
- 12 of the medicare population, or 23,191 individuals, as acceptable
- 13 performance and justification for continued funding. Additional
- 14 staffing resources are needed to meet this annual goal by fiscal
- 15 year 2025.
- 16 The purpose of this Act is to:
- 17 (1) Require the executive office on aging to submit annual
- 18 progress reports on the Hawaii state health insurance
- assistance program; and
- 20 (2) Appropriate funds for the Hawaii state health
- insurance assistance program for the establishment of

1	three program specialist positions within the
2	executive office on aging to meet the growing aging
3	population's increasing demand for accurate, timely,
4	and reliable services.
5	SECTION 2. Chapter 349, Hawaii Revised Statutes, is
6	amended by adding a new section to be appropriately designated
7	and to read as follows:
8	"§349- The Hawaii state health insurance assistance
9	program; annual report. The executive office on aging shall
10	submit to the legislature a progress report on the Hawaii state
11	health insurance assistance program no later than twenty days
12	prior to the convening of each regular session."
13	SECTION 3. There is appropriated out of the general
14	revenues of the State of Hawaii the sum of \$ or so
15	much thereof as may be necessary for fiscal year 2023-2024 and
16	the same sum or so much thereof as may be necessary for fiscal
17	year 2024-2025 for the establishment of one full-time equivalent
18	(1.0 FTE) program specialist III position, one full-time
19	equivalent (1.0 FTE) program specialist IV position, and one
20	full-time equivalent (1.0 FTE) program specialist V position

- 1 within the executive office on aging for the Hawaii state health
- 2 insurance assistance program.
- 3 The sums appropriated shall be expended by the executive
- 4 office on aging for the purposes of this Act.
- 5 SECTION 4. New statutory material is underscored.
- 6 SECTION 5. This Act shall take effect on December 31,
- 7 2050.
