## SENATE CONCURRENT RESOLUTION

REQUESTING THE COUNTIES TO UPDATE THE DESIGN AND FORMAT OF VEHICLE REGISTRATION PLATES IN RESPONSE TO GROWING ELECTRIC VEHICLE AND HYBRID VEHICLE SALES.

WHEREAS, it is in the best interest of the State to 1 effectively manage the distribution and circulation of vehicle 2 registration plates, also known as license plates or number 3 plates, especially as consumer trends in the automotive industry 4 rapidly change; and 5 6 WHEREAS, Hawaii's rainbow license plate design is nearing 7 the end of its current numbering pattern and will need to 8 9 change; and 10 WHEREAS, the people of the State are seeking alternatives 11 to gasoline-powered vehicles as gasoline prices rise and harmful 12 13 emissions continue to warm our climate; and 14 WHEREAS, hybrid vehicle sales have been increasing as 15 consumers view these vehicles as a convenient middle ground 16 between conventional gasoline-powered vehicles and electric 17 vehicles; and 18 19 20 WHEREAS, electric vehicle adoption is growing exponentially, with many major car manufacturers phasing out 21 gasoline-powered cars completely by 2035; and 22 23 WHEREAS, as a result, Hawaii's temporary electric vehicle 24 license plate numbering scheme needs to be changed to keep up 25 with this demand; and 26 27 WHEREAS, electric vehicle license plates in the State 28 currently use four characters, three of which are numbers and 29 one of which is a letter; and 30 31

WHEREAS, at the current pace of electric vehicle sales, the 1 current alphanumeric scheme will last for only five years; and 2 3 4 WHEREAS, updating the present license plate schemes is necessary to accommodate shifting trends for electric, hybrid, 5 and qasoline-powered vehicle sales in the State; now, therefore, 6 7 BE IT RESOLVED by the Senate of the Thirty-second 8 Legislature of the State of Hawaii, Regular Session of 2023, the 9 House of Representatives concurring, that the counties are 10 requested to update the design and format of vehicle 11 registration plates in response to the growing electric vehicle 12 and hybrid vehicle sales; and 13 14 15 BE IT FURTHER RESOLVED that beginning January 1, 2025, that the Director of Finance of each county is requested to issue 16 number plates in the following manner: 17 18 Number plates for electric vehicles should bear the 19 (1)word "Hawaii" along the upper portion of the plate and 20 the words "Aloha State" along the lower portion of the 21 plate and contain a colorful design reflecting the 22 23 State's unique environment; 24 Number plates for hybrid vehicles should bear the word (2) 25 26 "Hawaii" on the upper portion of the plate and the words "hybrid vehicle" on any portion of the plate and 27 28 use the rainbow design featured on number plates, except special number plates, issued in the State 29 beginning in 1991; and 30 31 32 (3) Number plates for gasoline-powered vehicles should bear the word "Hawaii" along the upper portion of the 33 plate and the words "gas vehicle" on any portion of 34 the plate and use the rainbow design featured on 35 number plates, except special number plates, issued in 36 the State beginning in 1991; and 37 38
