## SENATE CONCURRENT RESOLUTION

REQUESTING THE DEPARTMENT OF PUBLIC SAFETY TO CONVENE A WORKING GROUP TO MAKE RECOMMENDATIONS ON HOW TO IMPROVE SECURITY AT THE STATE CAPITOL.

WHEREAS, terrorism, violence, and threats of violence in 1 public forums have become increasingly common; and 2 3 WHEREAS, after the 2020 election, protestors forced their 4 way into the state capitols of Idaho, Michigan, and Oregon, and 5 the United States Capitol was breached by violent protesters on 6 7 January 6, 2021; and 8 9 WHEREAS, recent United States Supreme Court rulings have 10 made it easier for individuals to carry firearms in the State; and 11 12 13 WHEREAS, the Judiciary, co-equal to the legislative and executive branches of government, welcomes members of the public 14 to come to court and observe firsthand the administration of 15 justice - but also requires all visitors to first pass through 16 metal detectors and have their belongings undergo x-ray baggage 17 18 screening; and 19 20 WHEREAS, in contrast, the Hawaii State Capitol building is 21 known as one of the most publicly accessible capitol buildings in the nation, but is also one of the most vulnerable due to a 22 lack of similar security measures; and 23 24 WHEREAS, the State must do more to ensure that citizen 25 26 engagement does not come at the expense of public safety; now, therefore. 27 28 29 BE IT RESOLVED by the Senate of the Thirty-second Legislature of the State of Hawaii, Regular Session of 2023, the 30 House of Representatives concurring, that the Department of 31 Public Safety, Sheriff Division, is requested to convene a 32
