## SENATE CONCURRENT RESOLUTION

URGING THE PUBLIC WORKS DIVISION OF THE DEPARTMENT OF ACCOUNTING AND GENERAL SERVICES IN COLLABORATION WITH THE STADIUM AUTHORITY TO PROCURE A CONCESSIONAIRE TO DESIGN, BUILD, OPERATE, AND MAINTAIN THE NEW ALOHA STADIUM FACILITY.

WHEREAS, in December 2020, the Stadium Authority announced 1 2 that it would close Aloha Stadium indefinitely in preparation for a new stadium facility; and 3 4 WHEREAS, Act 248, Session Laws of Hawaii 2022, appropriated 5 \$350 million in general obligation bonds and \$50 million of 6 general funds for the development of the New Aloha Stadium 7 Entertainment District; and 8 9 10 WHEREAS, the Stadium Authority finalized the environmental impact statement for the New Aloha Stadium Entertainment 11 District in September 2022; and 12 13 WHEREAS, the Stadium Authority issued two requests for 14 proposal, one for the design, construction, financing, and 15 maintenance of the new stadium facility, and the second for 16 development of the New Aloha Stadium Entertainment District, 17 18 concurrently procured by a separate two-stage procurement process that involves a master developer partner and a 19 commercial development partner for the initial development of 20 21 the parcel; and 22 WHEREAS, the revenues generated from the development of the 23 24 New Aloha Stadium Entertainment District are intended to finance the new stadium facility; and 25 26 27 WHEREAS, any delay in the development of the New Aloha Stadium Entertainment District would require larger availability 28 payments, or long-term regular payments from the government to 29 the private consortium that designs, builds, finances, operates, 30 31 and maintains the new stadium facility, as there would be no

ongoing revenue stream from the New Aloha Stadium Entertainment 1 2 District; now, therefore, 3 BE IT RESOLVED by the Senate of the Thirty-second 4 Legislature of the State of Hawaii, Regular Session of 2023, the 5 House of Representatives concurring, that the Public Works 6 7 Division of the Department of Accounting and General Services in collaboration with the Stadium Authority is urged to procure a 8 concessionaire to design, build, operate, and maintain the new 9 stadium facility; and 10 11 BE IT FURTHER RESOLVED that the Public Works Division is 12 urged to include the development of the New Aloha Stadium 13 Entertainment District in the scope of its public-private 14 partnership contract with the concessionaire; and 15 16 BE IT FURTHER RESOLVED that in preparing the solicitation 17 with the concessionaire for the design, construction, operation, 18 and maintenance of the new stadium facility and the solicitation 19 for the development of the New Aloha Stadium Entertainment 20 21 District, the Public Works Division is urged to evaluate the procurement of the San Diego State University Mission Valley 22 Site Development and San Diego Snapdragon Stadium, which 23 24 includes the redevelopment of a stadium as well as the construction of mixed-used residential units; and 25 26 BE IT FURTHER RESOLVED that certified copies of this 27 Concurrent Resolution be transmitted to the Public Works 28 29 Administrator and Chairperson of the Stadium Authority. 30 OFFERED BY: TAMANTER 31 32
