SENATE CONCURRENT RESOLUTION

URGING THE COUNTY GOVERNMENTS TO REVIEW THEIR RESPECTIVE GOVERNMENT STRUCTURE TO IDENTIFY ORGANIZATIONAL RISKS OF CORRUPTION AND ETHICAL VIOLATIONS AND TO DEVELOP SYSTEMATIC IMPROVEMENTS TO SUCH RISKS.

WHEREAS, the House of Representatives adopted House 1 2 Resolution No. 9 (2022) to establish the Commission to Improve Standards of Conduct; and 3 4 WHEREAS, House Resolution No. 9 requests the Commission 5 ensure state laws and rules relating to standards of conduct of 6 public officers and employees contain clear standards, 7 enforcement, and penalties and provide recommendations to 8 increase awareness of, compliance with, and deterrent effects of 9 the Code of Ethics, lobbying laws, campaign finance laws, and 10 other relevant laws and rules; and 11 12 WHEREAS, pursuant to House Resolution No. 9, the Commission 13 to Improve Standards of Conduct convened regularly throughout 14 2022 to diligently review, discuss, and consider the issues 15 presented, submitted an interim report to the house of 16 representatives outlining areas of immediate and long-term 17 focus, then continued its work with input from the public and 18 invited individuals and agencies to issue a final report with 19 20 various recommendations and accompanying proposed legislation; and 21 22 WHEREAS, the strength and stability of our democratic 23 government rely upon the public's trust in government 24 institutions, including the expectation that officers act 25 ethically with prudence, integrity, and sound judgement; and 26 27 WHEREAS, an essential goal of the Commission was to provide 28 recommendations that would help restore public trust in 29

government and increase the level of transparency in its 1 operations and accountability of individuals; and 2 3 4 WHEREAS, the Hawaii State Constitution places a duty on all 5 civil servants to "exhibit the highest standards of ethical conduct"; and 6 7 8 WHEREAS, recent allegations of corruption and ethics 9 violations were made against several county officials throughout 10 the State; and 11 12 WHEREAS, in the City and County of Honolulu, several 13 Department of Planning and Permitting employees were charged 14 with and pled guilty to accepting bribes in exchange for expediting the permitting process for projects; and 15 16 17 WHEREAS, in the County of Hawaii, a former Hawaii County housing official was charged with and later plead guilty to one 18 19 felony charge of honest services wire fraud, after accepting 20 nearly \$2,000,000 in bribes and kickbacks in exchange for the approval of affordable housing credits; and 21 22 23 WHEREAS, in the County of Maui, a former Maui County 24 official was accused by federal prosecutors of taking \$2,000,000 25 in bribes to steer \$19,000,000 in contracts to certain companies 26 and charged with conspiracy to deprive the public of their right to honest services; and 27 28 29 WHEREAS, these events have shaken the public's trust in the strength and integrity of the county governments; and 30 31 32 WHEREAS, to implement the recommendations of the Commission to Improve Standards of Conduct, a review of each county's 33 government structure, including identifying problems and 34 35 developing systematic improvements that will prevent future situations involving corruption and ethical violations, is 36 needed to help restore the public's trust in government; now, 37 therefore, 38 39 40 BE IT RESOLVED by the Senate of the Thirty-second 41 Legislature of the State of Hawaii, Regular Session of 2023, the 42 House of Representatives concurring, that the county governments
