# SENATE RESOLUTION

REQUESTING THAT THE PROVISION OF GOODS TO STATE AGENCIES FROM THE CORRECTIONAL INDUSTRIES PROGRAM BE LIMITED TO THOSE GOODS PRODUCED OR SUBSTANTIALLY ALTERED BY THE PROGRAM.

1           WHEREAS, the Administrator of the Correctional Industries  
2 Program of the Department of Public Safety is required to  
3 establish programs that provide essential products and services  
4 for each of the State's correctional facilities, for other state  
5 agencies, and for the counties, as may be required; and  
6

7           WHEREAS, the Director of Public Safety or the Director's  
8 designee may consult with the Administrator of the State  
9 Procurement Office to identify goods or services that the  
10 Correctional Industries Program may produce or provide to any  
11 state agency; and  
12

13           WHEREAS, the Administrator of the State Procurement Office  
14 is required to provide a list of goods and services available  
15 from the Correctional Industries Program, and any state agency  
16 may purchase these goods and services from the correctional  
17 industries program; and

19           WHEREAS, all goods provided by the Correctional Industries  
20 Program should be produced by the Correctional Industries  
21 Program, or goods substantially altered by the program; now,  
22 therefore,  
23

24           BE IT RESOLVED by the Senate of the Thirty-second  
25 Legislature of the State of Hawaii, Regular Session of 2023,  
26 that the Department of Public Safety and State Procurement  
27 Office are requested to agree that the provision of goods to  
28 state agencies from the Correctional Industries Program be  
29 limited to those goods that are:

- 31           (1) Produced or manufactured by the program; or

33           (2) Pre-existing goods that are substantially altered or  
34 customized by the program for the purpose of  
35 facilitating use of the goods by a state agency; and

1 BE IT FURTHER RESOLVED that the Department of Public Safety  
2 and its Director are requested to continue to follow the  
3 limitations requested by this measure when the Department of  
4 Public Safety is renamed the Department of Corrections and  
5 Rehabilitation pursuant to Act 278, Session Laws of Hawaii 2022;

9 Resolution be transmitted to the Director of Public Safety,  
10 Administrator of the Correctional Industries Program of the  
11 Department of Public Safety, and Administrator of the State  
12 Procurement Office.
