SENATE RESOLUTION

REQUESTING THE GOVERNOR TO CONVENE A TASK FORCE TO EXAMINE AND MAKE RECOMMENDATIONS ON THE EXISTING PROCEDURES FOR THE ADOPTION OF THE STATE BUILDING CODE.

WHEREAS, a 2019 study by the Department of Business, Economic Development, and Tourism found that the State will require an additional 50,156 homes by the year 2025, with the City and County of Honolulu requiring 22,168 new units, Hawaii County requiring 13,303 new units, Maui County requiring 10,404 new units, and Kauai County requiring 4,281 new unit; and

WHEREAS, there has been a lack of measurable progress at the county level to enact policies that will stimulate housing production to meet the projected demand; and

WHEREAS, existing laws and county procedures regarding the adoption and implementation of building codes impede the building permit process; and

WHEREAS, the State Building Code Council is responsible for establishing a state building code through the timely adoption of national building codes, which is based on:

- (1) The state fire code, as adopted by the State Fire Council;
- (2) The Uniform Plumbing Code;
- (3) The International Building Code, International Residential Code, and International Energy Conservation Code, as published by the International Code Council;
- (4) The National Electrical Code, as published by the National Fire Protection Association; and
