Your Committee on Conference on the disagreeing vote of the House of Representatives to the amendments proposed by the Senate in H.B. No. 1020, S.D. 1, entitled:

"A BILL FOR AN ACT RELATING TO PAYMENT OF CLAIMS OF THE UNCLAIMED PROPERTY PROGRAM,"

having met, and after full and free discussion, has agreed to recommend and does recommend to the respective Houses the final passage of this bill in an amended form.

The purpose of this measure is to increase the amount of funds that can be carried over on June 30 of each fiscal year in the Unclaimed Property Trust Fund.

Your Committee on Conference has amended this measure by:

- Changing the amount of funds that can be carried over at June 30 of each fiscal year to \$3,000,000;
