"A BILL FOR AN ACT RELATING TO THE BUDGET OF THE OFFICE OF HAWAIIAN AFFAIRS,"

having met, and after full and free discussion, has agreed to recommend and does recommend to the respective Houses the final passage of this bill in an amended form.

The purpose of this measure is to appropriate funds for the operating costs of the Office of Hawaiian Affairs for the fiscal biennium beginning July 1, 2023, and ending June 30, 2025.

Your Committee on Conference has amended this measure by:

- Appropriating \$3,000,000 for fiscal biennium 2023-2025 for the Office of Hawaiian Affairs;
- (2) Adding the requisite information for making an appropriation in excess of the general fund expenditure
