Your Committee on Conference on the disagreeing vote of the House of Representatives to the amendments proposed by the Senate in H.B. No. 192, H.D. 2, S.D. 1, entitled:

"A BILL FOR AN ACT RELATING TO ENERGY EFFICIENCY,"

having met, and after full and free discussion, has agreed to recommend and does recommend to the respective Houses the final passage of this bill in an amended form.

The purpose of this measure is to prohibit the sale of certain fluorescent lamps as a new manufactured product, with certain exemptions.

Your Committee on Conference has amended this measure by:

 Specifying that the prohibition on the sale of a screw or bayonet base type compact fluorescent lamp and a pin-base type compact fluorescent lamp or linear fluorescent lamp as a new manufactured product shall begin on January 1, 2025, and January 1, 2026, respectively; and
