- (1) Include electronic smoking devices and e-liquids under the definition of "tobacco products" for purposes of cigarette tax and tobacco tax law; and
- (2) Repeal the Electronic Smoking Device Retailer Registration Unit under the Department of the Attorney General.

Your Committee received

testimony in opposition to this measure from the Consumer Choice Center, Americans for Tax Reform, Hawaii Smokers Alliance, Taxpayers Protection Alliance, National Taxpayers Union, and eight individuals. Your Committee received comments on this measure from the Department of Taxation, Department of the Attorney General, Department of Health, Hawaii Substance Abuse Coalition, Hawai'i Children's Action Network Speaks!, Tax Foundation of Hawaii, Campaign for Tobacco-Free Kids, American Cancer Society Cancer Action Network, and two individuals.

As affirmed by the record of votes of the members of your Committee on Finance that is attached to this report, your Committee is in accord with the intent and purpose of H.B. No. 537, H.D. 2, and recommends that it pass Third Reading.
