Your Committee on Health & Homelessness, to which was referred H.C.R. No. 187 entitled:

"HOUSE CONCURRENT RESOLUTION URGING THE HAWAII EMERGENCY MANAGEMENT AGENCY TO INCLUDE IN ALL LIVE AND RECORDED EMERGENCY ALERT SYSTEM VIDEO BROADCASTS, AN ON-SCREEN INTERPRETER DISSEMINATING THE EMERGENCY INFORMATION IN AMERICAN SIGN LANGUAGE AT ALL TIMES, INCLUDING DURING GRAPHIC PRESENTATIONS,"
