Your Committee on Judiciary & Hawaiian Affairs, to which was referred H.C.R. No. 63 entitled:

"HOUSE CONCURRENT RESOLUTION REQUESTING THE ATTORNEY GENERAL TO CONVENE A TASK FORCE TO RESEARCH THE LAWS, ORDINANCES, AND RULES PROHIBITING CONDUCT ON OR NEAR SCHOOL GROUNDS, OR FOR THE GENERAL PROTECTION OF CHILDREN ATTENDING SCHOOL, AND TO DISTRIBUTE A SUMMARY OF THOSE LAWS TO STATE AND COUNTY BUILDINGS FOR PUBLIC DISPLAY,"

begs leave to report as follows:

The purpose of this measure is to request the Attorney General to convene a task force to research the laws, ordinances, and rules prohibiting conduct on or near school grounds, or for the general protection of children attending school, and to distribute a summary of those laws to State and County buildings for public display.

Your Committee received testimony in support from five individuals. Your Committee received testimony in opposition from the Attorney General.

Your Committee has amended this measure by replacing the Attorney General with the Legislative Reference Bureau. Your Committee has also amended this measure by deleting the references

to convening a task force and asking the Legislative Reference Bureau instead solely to conduct research.
