Your Committee on Transportation, to which was referred H.R. No. 21 entitled:

"HOUSE RESOLUTION URGING THE COUNTIES TO IMPLEMENT AND ENFORCE REGULATIONS THAT ENSURE CAR SHARING SERVICES AND OPERATIONS DO NOT NEGATIVELY IMPACT THE TRAFFIC, PARKING, AND CHARACTER OF RESIDENTIAL NEIGHBORHOODS,"

The purpose of this measure is to urge the counties to implement and enforce regulations that ensure car sharing services and operations do not negatively impact the traffic, parking, and character of residential neighborhoods.
