Your Committee on Conference on the disagreeing vote of the Senate to the amendments proposed by the House of Representatives in S.B. No. 1493, S.D. 1, H.D. 1, entitled:

"A BILL FOR AN ACT RELATING TO LOBBYISTS,"

having met, and after full and free discussion, has agreed to recommend and does recommend to the respective Houses the final passage of this bill in an amended form.

The purpose of this measure is to prohibit, during legislative sessions and shortly before and after, lobbyist contributions and expenditures, and promises of contributions or expenditures, to any elected official, candidate, candidate committee, or individual who is required to file an organizational report with the Campaign Spending Commission.

Your Committee on Conference finds that contributions made during legislative sessions, including extended sessions or special sessions, can create the perception that the contribution has the intent or effect of influencing decisions being taken on pending legislation. Restricting lobbyists from donating to an elected

official during a legislative session will further the goal of reducing undue influence and its appearance.

Your Committee on Conference has amended this measure by making it effective upon its approval.
