The purpose of this measure is to:

- Require the Office of Enterprise Technology Services, in (1)consultation with the Office of Language Access and a working group, to develop and publish, and periodically review and update, electronic information technology standards for multilingual accessibility to be implemented by all state entities; and
- (2) Appropriate funds for one program manager position in the Office of Enterprise Technology Services.
