"A BILL FOR AN ACT RELATING TO SPECIAL PURPOSE DIGITAL CURRENCY LICENSURE,"

begs leave to report as follows:

The purpose of this measure is to:

- Establish a Special Purpose Digital Currency License Program to replace the Digital Currency Innovation Lab; and
- (2) Allow, for six months, any company participating in the Digital Currency Innovation Lab on June 30, 2023, to continue operations if a complete application for licensure is submitted to the Division of Financial Institutions by March 1, 2024.

Your Committee received testimony in support of this measure from the Hawaii Technology Development Corporation and two individuals. Your Committee received testimony in opposition to this measure from eight individuals. Your Committee received comments on this measure from the Department of Commerce and

Consumer Affairs, Grassroot Institute of Hawaii, and Cryptokenikeni Project.

Your Committee has amended this measure by:

- Changing the appropriation out of the Compliance Resolution Fund to an unspecified amount;
- (2) Changing the effective date to June 30, 3000, to encourage further discussion; and
- (3) Making technical, nonsubstantive amendments for the purposes of clarity, consistency, and style.


