"A BILL FOR AN ACT RELATING TO BOARDS OF REGISTRATION,"

begs leave to report as follows:

2023-2734 SB9 SD1 HSCR HMSO

The purpose of this measure is to:

- Require members of each board of registration be a registered voter in the respective county of the board to which the member is appointed and remain a registered voter in that county for their term of office; and
- (2) Establish methods for determining and verifying a board member's political party membership.

Your Committee received testimony in support of this measure from the League of Women Voters of Hawaii and one individual.

Your Committee finds that board of registration volunteers play an important role in maintaining election integrity by reviewing and deciding appeals that arise from a voter challenge or a clerk's decision regarding voter registration. Your Committee further finds that establishing a method for determining and verifying a board member's party affiliation will ensure each board of registration avoids overt bias and maintains the ability

to make fair decisions concerning voter appeals and a clerk's decision.
