TCA, CPN Requires hourly peer-to-peer car sharing operators to insure the (SSCR278) shared car with personal injury protection benefit and basic liability coverage. Authorizes the Department of Transportation Status & to regulate peer-to-peer car share parking at state airports. **Testimony** Authorizes the counties to regulate peer-to-peer parking on county streets. Takes effect 7/1/2050. (SD1) RELATING TO REAL PROPERTY DISCLOSURES WITHIN WTL, CPN **SB 1389, SD1** SHORELINE AREAS. (SSCR139) Requires mandatory disclosure of all existing permitted and Status & unpermitted shoreline erosion control structures and the annual coastal erosion rates for shoreline properties in real estate **Testimony** transactions. Effective 7/1/2050. (SD1) RELATING TO ENVIRONMENTAL PROTECTION. **SB 504** AEN, CPN Beginning 12/31/2026, prohibits the manufacture, sale, offer for (SSCR91) sale, distribution for sale, and distribution for use of any food packaging, food service ware, cosmetic, or personal care Status & product that contains perfluoroalkyl and polyfluoroalkyl **Testimony** substances. **SB 506** RELATING TO CONSUMER PROTECTION. AEN, CPN Requires self-service stations to put labels on gas dispensing (SSCR92) equipment that advise consumers on the effects of fossil fuel consumption to human health and the environment. Status & **Testimony SB 516** RELATING TO HEMP. AEN, CPN Requires that the identity statement used for labeling or (SSCR246) advertising hemp products identify the percentage of Hawaii grown hemp and hemp of other origins contained in hemp Status &

products. Effective 6/29/2023.

RELATING TO COFFEE LABELING. **SB 746** AEN, CPN Expands the coffee labeling and advertising requirements to (SSCR247) include ready-to-drink coffee beverages and inner packages and inner wrapping labels. Requires disclosure on the label of Status & coffee blends of the respective geographic and regional origins Testimony and per cent by weight of the blended coffees. Prohibits use of the term "All Hawaiian" in labeling or advertising for roasted coffee or instant coffee not produced entirely from green coffee beans grown and processed in Hawaii. **SB 756** RELATING TO ECONOMIC DEVELOPMENT. AEN, CPN Establishes the Access to Local Food Act to allow cottage food (SSCR579) operations to sell cottage food products, under certain Status & conditions, upon receiving a permit from the Department of Health. **Testimony**
