RELATING TO CLIMATE CHANGE.

EEP/WAL, FIN

Establishes the Climate Impact Special Fund, allocates five cents from the Environmental Response, Energy, and Food Security Tax to the Climate Impact Special Fund, and appropriates funds to the Hawaii Climate Change Mitigation and Adaptation Commission to address impacts of climate change and to mitigate further impacts on the State through carbon sequestration and resiliency planning, allocates funds to the sea level rise voluntary relocation fund.

HB 1212 Status

RELATING TO WATER NEUTRALITY.

EEP/WAL, FIN

Establishes the water neutrality task force to develop a plan for Hawaii to become water-neutral by the year 2050. Requires the task force to submit a report to the Legislature.

DECISION MAKING TO FOLLOW

Persons wishing to offer comments should submit testimony at least <u>24 hours</u> prior to the hearing. Testimony received after this time will be stamped late and left to the discretion of the chair to consider.
