SB 1510 RELATING TO UNIVERSITY OF HAWAII ASTRONOMY HRE/EET, WAM

Status & ENGINEERING AND INSTRUMENTATION.

Establishes a center for design, development, and fabrication of astronomical instruments within the University of Hawaii.

Appropriates funds for the center's planning and design and ten

full-time equivalent faculty positions within the center.
