GENERATING SYSTEMS.

Requires the counties to exempt from county permitting requirements the installation of off-grid residential photovoltaic energy generating systems on the rooftops of residential properties, under certain circumstances. Effective 6/30/3000. (HD1)

RELATING TO BUILDINGS.

Requires state agencies to process the aggregated energy and water data of certain properties through the federal ENERGY STAR Portfolio Manager and submit the benchmarking data to the Hawaii state energy office. Appropriates funds. Effective 6/30/3000. (HD2)

RELATING TO TOURISM.

EET/PSM, WAM

Establishes the powers, duties, and responsibilities of the destination management agency, including its director and commission. Establishes the tourism special fund and county assistance special fund, to receive allocations from transient accommodations tax revenue. Repeals the Hawaii tourism authority. Effective 6/30/3000. (HD3)
