Requires the board of education to work with the department of education to conduct an analysis on the need, impact, and feasibility of making computer science a graduation requirement. Requires the board to determine whether making computer science a graduation requirement would be in the best interests of public school students and the public. Requires a report to the legislature. Appropriates funds for teacher professional development in computer science. Effective 7/1/3000. (HD2)

HB 942, HD2 (HSCR621) Status

RELATING TO EMERGENCY MEDICAL RESPONSE.

EDN, HLT, FIN

Requires each department of education school and public charter school to establish a critical emergency response team. Appropriates funds. Effective 6/20/2000. (IDD)

HB 1412, HD1 (HSCR340) Status RELATING TO LIBRARIES.

EDN, FIN

Prohibits any contract or license agreement between a publisher and library in the State from precluding, limiting, or otherwise restricting the library from performing customary operational and lending functions; restricting the library from disclosing any terms of its license agreements to other libraries; and requiring, coercing, or enabling a library to violate rules regarding confidentially of a patron's library records. Deems contracts that contain prohibited provisions an unfair or deceptive act or practice and void and unenforceable. Effective 6/30/3000. (HD1)

<u>HB 258, HD1</u> (<u>HSCR629</u>) <u>Status</u> RELATING TO THE ACQUISITION OF THE SAINT FRANCIS SCHOOL CAMPUS FOR THE UNIVERSITY OF HAWAII AT MANOA.

HET, FIN

Appropriates moneys to the University of Hawaii for the acquisition of the Saint Francis School campus located at 2707 Pamoa Road in Honolulu. Effective 6/30/3000. (HD1)

HB 1430, HD1 (HSCR688) Status RELATING TO THE UNIVERSITY OF HAWAII AT HILO. Establishes the institute of indigenous education, science, and outreach within the University of Hawaii at Hilo. Effective 6/30/3000. (HD1)

<u>HB 617, HD1</u> (<u>HSCR727)</u> <u>Status</u> RELATING TO ORAL HEALTH.

HLT, FIN

Establishes an oral health task force to review the status of oral health in the State and make recommendations to improve oral health infrastructure in Hawaii. Appropriates funds. Effective 6/30/3000. (HD1)

<u>HB 622, HD2</u> (<u>HSCR525</u>) Status RELATING TO SUICIDE PREVENTION.

HLT, JHA, FIN

Makes permanent the prevent suicide Hawaii task force within the department of health. Requires the task force to focus on reducing the suicide rate among Native Hawaiians and Pacific Islanders in the State. Requires reports to the legislature. Effective 6/30/3000. (HD2)

<u>HB 1301, HD1</u> (<u>HSCR702</u>) Status RELATING TO CANCER.

HLT, FIN

Appropriates funds to the University of Hawaii cancer center to conduct a multi-ethnic cohort study focusing on the social determinants of health, lifestyles, environmental exposures, and resilience factors of Native Hawaiians, Pacific Islanders, and Filipinos. Effective 6/30/3000. (HD1)

## RELATING TO THE FUEL TANK ADVISORY COMMITTEE.

Requires the Fuel Tank Advisory Committee to hold no fewer than one regular meeting in each quarter of a calendar year. Appropriates funds. Effective 6/30/3000. (HD1)
