HB 126 Status	RELATING TO PUBLIC CORRUPTION. Increases the penalties for bribery under certain circumstances. Amends the offense of obstruction of justice to include obstruction by force, threat of force, coercion, fraud, or deception.	JHA, FIN
HB 383 Status	RELATING TO THE UNIFORM PROBATE CODE. Updates articles I through IV of the Uniform Probate Code to adjust for inflation, provide additional clarity, resolve issues that have arisen in probate practice, and address societal changes in familial relations.	JHA, FIN
HB 68 Status	RELATING TO CRIMINAL JUSTICE. Appropriates funds to establish a centralized statewide criminal pretrial justice data reporting and collection system pursuant to state law.	JHA, FIN
