SB 787 RELATING TO THE EMPLOYEES RETIREMENT SYSTEM.

Status & Authorizes a court to order the forfeiture of all of the Employees'

Testimony Retirement System (ERS) benefits of an ERS member, former

Retirement System (ERS) benefits of an ERS member, former member, or retirant upon conviction of the individual for a felony related to the State or county employment of the individual. Prohibits designated beneficiaries convicted of a felony under the same set of circumstances as the member, former member, or retirant who was subject to forfeiture of ERS benefits from
