Re: Governor's Message No. 512 Nomination of Catherine Betts to the position of Director of Department of Human Services

This letter is in response to Governor's Message No. 512, regarding your nomination to the position of Director of the Department of Human Services. To assist the Senate with its constitutionally mandated responsibility to confirm gubernatorial nominees, submission of the following information is required:

(1) A description of your experience in the field of Human Services, or any related field;

I have worked in various capacities in this field for the last twenty years: beginning in 2001 as an outreach worker with the Sex Abuse Treatment Center where I worked with intermediate and high school students to educate them about safe relationships, domestic violence, and sexual assault; to my work as a deputy AG where I represented the Department of Human Services-Child Welfare Services Branch. That experience was particularly eye-opening for me, as I was able to see the various needs of the department and also witness the difficult and traumatic work our workforce endures every day on the job. In 2011, I was appointed as the Exec. Director for the Hawaii State Commission on the Status of Women (administratively attached to DHS) and worked closely with our DHS leadership on various legislation pertinent to women and girls (with a specific focus on economic justice, violence prevention, and access to reproductive healthcare). In 2017, I was appointed as Deputy Director and consider myself lucky to have been mentored by former Director Pankaj Bhanot. I served as Deputy until 2020, then was appointed to the Director position just a few months into the pandemic. For the last five years, I have overseen all policy, budget, and administrative decisions for the department. Additionally, I have increased cross sector collaboration with our community stakeholders, non-profit organizations, and national policy organizations (APHSA, NGA, etc.) to increase our department's ability to remain collaborative, innovative, and creative in the ways we approach the work we do.

(2) An assessment of your strengths and weaknesses;

Strengths: I pride myself on being an honest and caring hard worker. I am a self-starter and enjoy finishing projects through completion. I appreciate thoroughness, competence, honesty, diligence, compassion, empathy, and integrity. I was raised to see true value in hard work and humility. I can learn new things quickly, which is a benefit to me in this large department with competing interests, various federal funding streams, and various ongoing initiatives. Additionally, I can balance many different ongoing projects and see things through to fruition. I consider myself a strong mentor and staff come to me for assistance with their professional development, training, and advancement. I can assess complex and difficult situations quickly and comprehensively to plan for the best possible outcome. In emergency or crisis situations, I have the ability to make quick, sensible solutions.

Weaknesses: Prior to the pandemic, I had difficulty detaching from my work. The pandemic's pace and impact only exacerbated that. I recognize that I need to take better care of myself to have longevity in this career.

(3) An assessment of the department's strengths and weaknesses. Please include an explanation of how the department's strengths may be best utilized, as well as how the department's weaknesses may be improved;

Strengths: DHS is a single state agency designated to receive federal funds to administer various programs, including Medicaid, TANF, SNAP, Child Care, Child Welfare, Vocational Rehabilitation, Youth Services and Public Housing. During the pandemic, leadership and our dedicated staff were able to quickly apply for and receive federal waivers for various programs as well as administer several rounds of pandemic relief funds (child care subsidies, child care provider grants, child welfare funds, adult protective funds, Medicaid, homeless funds, etc). Although we recognized previously that DHS was functionally well organized and poised to respond to crises/emergency situations, this was well proven and validated throughout the last three years of the pandemic. Our ability to transition quickly to administer hundreds of millions of dollars in relief funds is also a testament to the caring and dedicated individuals who work for the department. We have strong, dedicated, and committed leadership throughout our department and that has only strengthened and evolved over the last three years.

Weaknesses: Human Services organizations across the country are experiencing a difficulty in filling critical positions and retaining current staff due to the pandemic's impact on stress and burnout. After three years of pandemic response, we have to evolve into a modern employer in order to attract, recruit, and retain staff. This means we need to understand the needs of younger employees, especially employees who have caregiving responsibilities. Additionally, we have to create better paying positions with positive upward mobility in order to keep the staff we have and provide leadership training opportunities. This is not something that government or civil service positions were designed to do.

Additionally, we desperately need another deputy to be able to help lead an ever-growing department. Just last year, a new unfunded commission was legislatively attached to DHS. Additionally, we received one year funding for various programs that take time to set up, draft and complete administrative rules for, and procedurally set up. We require additional high-level staff to be able to accomplish the will of the legislature.

(4) An overall vision for the department, specifically what goals can be accomplished within the next four years and what types of annual benchmarks can be used to evaluate the department's progress towards those goals;

(6) An assessment of the department's staff morale, including the turnover rate for personnel; and

Human Services workforces have suffered across the nation during the pandemic. Workers have dealt with unimaginable trauma, crisis, and emergency response in their workplaces as well as in their own homes. Consequently, many of our most experienced workers who were at retirement age have chosen to retire. Additionally, workers who have felt burnt out or "quietly quit" have left our workforce to find better and more lucrative opportunities in the private sector. Nonetheless, many of our dedicated and committed employees have stayed on. Staff morale is oftentimes dependent on adequate, compassionate, and supportive supervisors. I can attest that staff morale remained high when I was reappointed. When a new person takes on this critical role, it does have an impact on staff who do not know how a new person in this role will treat them. Throughout the pandemic, I have made it clear to all staff, regardless of their position in our "hierarchy", that their mental health and families matter. We cannot do this difficult work without taking care of ourselves and ensuring our families are safe and healthy. I will note that incendiary and oftentimes untruthful depictions of child welfare workers and eligibility workers in the media takes a toll on our workers morale. It is impossible to know the complexity and difficulty of their work without seeing them in the field every day. My role is tasked with ensuring they are able to do their jobs successfully and ethically, while also allowing them to feel heard and seen as dedicated employees to the department.

(7) Any foreseeable possible conflicts of interest that could arise during your service in the department and how you would overcome them.

I don't foresee any conflicts of interest. I regularly consult with the Hawaii State Ethics Commission, the departments deputies AG, and my internal team to make the best ethical decisions.

I continue to serve on the Board of Directors for the Hawaii Filipino Lawyers Association and the Committee on Equality and Access to the Courts (CEAC). I have served on these committees in various capacities over the last decade. Currently, no board I serve on receives any funds from DHS, nor do they have any issues or lawsuits before the department.

Good afternoon, Chair San Buenaventura Vice Chair Aquino, and Members of the Committee:

I would like to thank you for hearing this GM today and would also like to extend my appreciation for being able to share a few words with you today.

I could not and would not be considered here today without the incredible team of leaders behind me. The last three years were relentless and difficult. However, they also reminded me of the goodness and kindness of humanity, and the many reasons why I chose a career in public service. This department was tasked with protecting and caring for Hawaii's residents during a global pandemic; we all had initial moments of panic and crisis and terror. We took a deep breath, and then we rolled up our sleeves and got to work. We worked evenings, weekends, and every other time in between to ensure our safety net services could be accessed and viable for Hawaii's residents. Our greater community came together to ensure we met the needs of our most vulnerable residents. My greater DHS 'ohana -- a team of hard working, dedicated, and caring individuals -- came together to ensure a rising sea could lift all boats.

Together, we expended hundreds of millions for child care, P-EBT, and SNAP benefits.

Our Medicaid program now covers 467,000 individuals in the state. Additionally, Hawaii became the first state in the nation to implement Medicaid coverage for residents from Compact Nations.

In our Benefit, Employment, and Support Services Division, we assisted more than 190,000 individuals to ensure they could receive supplemental nutritional benefits, and we recently became the first state in the nation to have our Pandemic EBT plan approved by the federal government.

We worked alongside our legislative partners in the House and Senate to ensure we could use TANF for housing assistance. And, we partnered with our community stakeholders and partners to implement Family Resource Centers and expand civil legal services to houseless individuals.

We worked with WIC to ensure that families who are eligible for WIC can also access needed SNAP benefits. And, we worked with law enforcement and the Attorney General's office to recover foster youth who were being trafficked on the street.

And, our Office of Youth Services reached a goal of having zero girls incarcerated.

I have served this department through four different directors and four different governors and I can safely say that we have changed the way state government functions. By implementing organizational change management, IT modernization, and our Ohana Nui framework, we have proven to staff and residents that government does not need to be entrenched in the past nor does it need to be business as usual. We can think outside of the box, we can care for residents and our staff, and we can do things differently and more efficiently.

At the core of the work I do, I always remember survivors. Survivors are why I strive to make a more equitable system and why I care as much as I do about the work this department does. No one should have to navigate a system set up to imitate a labyrinth, just to get job training, supplemental nutrition, or health care. I will always have the heart of an advocate, and I am grateful for this opportunity you have afforded me.

My vision for this department is simple. We continue to care for individuals and families that need it, we invest in our staff to ensure they are equipped with best practices, trauma informed care, and information, and we invest in our technology to continue de-siloing our government legacy systems that no longer serve us. At the end of the day, we must serve Hawaii's residents with transparency, efficiency, and integrity. I would like to thank Governor Green for appointing me in this role, and I would like to thank you for this opportunity and humbly request your support.

What is disputed is her capacity and her ability to carry out her job duties as Director of DHS and the Child Welfare Services (CWS) division.

DHS and the CWS Division is a challenging position that requires truth and accuracy when dealing with the Family Court. Ms. Betts has not shown, nor has she been responsive to many requests to follow up on cases where there has been clear evidence regarding conflicts of interest, fraudulent reporting, omission of exculpatory evidence and Constitutional Violations under both the United States Constitution and the Hawaii state constitution specifically addressing the 4th Amendment, the right to be free of illegal search and seizure and of 14th Amendment, which addresses the right to Due Process, which includes the right to be presumed "innocent until proven guilty." Currently DHS and CWS continue to violate these rights with impunity. In the CWS "System," parents are automatically presumed "guilty until proven innocent," which is prohibited in any other court of law.

As an independent consultant and victim advocate, I have consulted many families involved in Criminal Court, Civil Court and Family Court. I have advised parents to document their concerns and to provide grievances in writing to CWS and directly to Ms. Betts. To date, reports by parents confirm that multiple phone calls/emails were sent during their cases for which there was no response. Parents had or continue to have no home visits. Parents who contested the allegations have waited for more than a year for adjudication, while caseworkers were non-responsive and retaliatory. Parents who have completed all "recommended" services are still awaiting reunification with their children. These above actions or non-actions are often referred to as "institutional neglect."

In the recent high-profile case involving the murder of Ariels Sellers (aka Isabella Kalua) her siblings were split up and the oldest sibling (13) who is also a victim/witness to a crime, is currently placed in a facility which also holds youth status offenders. Ariels older sibling has reported being threatened, punched, and intimidated by other youth in the facility. The sibling reported these events to the CWS Social Worker, and no action was taken. In addition, a biological aunty of the siblings has been asking, from the

beginning, to have the siblings placed with her. CWS SW denied the aunty any involvement in the case since she was not "blood related." This is not true or accurate and the aunty continues to fight for placement.

Currently, the aunty has filled out all necessary documentation requesting placement. She has completed all foster care licensing requirements. She has completed all training and has had four walk throughs of her home. A Home Study was completed but has not been submitted to the court. The aunty signed a *consent to release* the Home Study Report to the family court. CWS SW told aunty she would "think about it." Again, another example non-action or "institutional neglect."

The high-profile case of Ariel has once again highlighted the flaws in the system. The same flaws have been outlined via independent audits as far back as 1989. These flaws have also been addressed in the most recent articles published by investigative reporter John Hill from Civil Beat. John Hills series entitled *"Hawaii vs. Parental Rights,"* has also highlighted the same concerns that have been discussed for over twenty years and still DHS and CWS operates under the system of secrecy, and they hide behind the *"cloak of confidentiality."* Ms. Betts has continued and remains unresponsive to the needs of those involved in the flawed CWS system. At this time, and for the above reasons, I do NOT support the confirmation of Catherine Betts Director, Department of Human Services.

My names is Joshua Franklin; I have been a family advocate on Hawaii Island for the last decade. I have found the Department of Human Services to be broken and filled with corruption, including a lack of training or blatant disregard for laws to protect citizens. This past year I have been appalled at numerous family cases as I have witnessed bias, discrimination, and fraud. I have contacted Ms. Betts's office numerous times on multiple issues involving different families and concerns with social workers to no avail. Despite sending her irrefutable evidence of professional misconduct, Ms. Betts has refused to meet with me. She has advocated for this behavior through her lack of response. The Department now has advised me that they will not speak to me, and I have been prohibited from asking any questions on case files even after a formal privacy release has been signed. Cathy Betts is aware of this. I was retaliated by and

through C.W.S. in association with Parents Inc as one of the fathers I represent audio recorded a supervised visit of which a fraudulent report was produced. If not for the audio, we would have no proof that the agency actively is advocating for parental alienation of fathers from children. We have a systemic issue of discrimination against fathers, yet Ms. Betts refuses to address this issue. Shortly after this, I was blackballed by Parents Inc regarding employment opportunities as their supervisor then, Sossity Rapoza accidentally sent me an email indicating that she planned not to give me an interview. She was terminated only after the agency couldn't deny this attempted retaliation. I fear the agency is corrupt and have asked for an internal investigation to the act of fraud yet have not gotten any response from Ms. Betts, The Department of Human Services Is aware P.A.R.E.N.T.S. Inc supports parental alienation and professional misconduct up and including doctoring up false narratives of supervised visitation reports and having illegal hiring practices. Child Welfare is understaffed, leading to bias and prejudice guiding some social workers' cases. It's simply "less work" to discriminate against certain families or individuals. I am currently dealing with multiple cases of fraud, committed perjury, defamation, and retaliation. I remain highly concerned that Ms. Betts's lack of response is due to her lack of passion for her position, as she has not taken her directorship seriously. We need someone accountable and responsive at the very least.

Committee members,

I have been helping families understand their rights in the child welfare system and supporting legislative reform for 10 years.

I oppose the confirmation of Ms. Betts for the following reasons.

She has been either the second in command or Director of DHS for the past 5 years. During that time,4 children died while in foster care, according to the DOH report to the legislature by the death review board, 2 children died at the hands of parents after extensive contact with DHS. There has been no transparency to the public regarding the causes of death or improvements made to prevent those deaths.

In 2016, I was told that CWS needs no warrant to remove a child from a parent. Since then, Civil Beat has published the truth about the lack of training on the constitutional rights of families or the statutory laws that govern child protection. Ms. Betts has had two years to implement warrant training since professional power-point training was made available to the department in November 2020.

I've seen countless disregard of the law and policies of DHS by caseworkers. Parents have sent hundreds of emails and made phone calls to caseworkers all the way up to the Director's office. I can't remember that any parent ever received a response.

It's time for leadership in the department by someone who first and foremost understands the right of parents to raise their children without government intervention unless there is due process and a leader who will hold the entire department accountable for training and compliance with its own laws and directives.

Hawaii's former DHS Director Lillian Koller was subject to a Senate investigation when two children died under her watch as DSS Director in South Carolina. She resigned after having been given a vote of "no" confidence due to a testimony that was defensive and offered no solutions to the accountability of the department.

A new Director in the South Carolina Department admitted on the record that the agency cannot guarantee the safety of children in state care. It's time for a leader in Hawaii who will admit that the Child Welfare Division is gravely in need of reform and who can articulate the measures that will be taken to address that.

There have been 21 lawsuits filed or settled against the Child Welfare Division of DHS since 2013. 4 are currently active and another is pending. That is too many and a direct reflection of the competency of the Director. The public should not have to foot the bill for indifference to the need for strong leadership.

The state cannot afford another Ariel Sellers' tragedy while a working group seeks to recognize what has already been published by experts for decades. The lack of training and due process contributes to case overload and the ripple effect of unnecessary child deaths. The public deserves transparency and accountability from its Directors of government departments.

I have not seen her since. There was no response to Child Welfare or concern that I was being alienated. Today I pray daily that I will be able to see my children and attain custody of them as their mother has and will continue to subject them to psychological violence. I found the Hilo Child Welfare office not to have any training regarding fathers who are alienated, as I spent thousands of dollars on psychosexual assessments, which stated I am not a pedophile. I called Betts office numerous times to never get my calls returned as staff stated they would have someone call me back, but they never have. Here I am years later, broken. I have been depressed and saddened over this. It is only with strong prayer and meditation that I have been able to continue. I fear I am not the only father affected by this and fear my children are not the only ones harmed by Ms. Betts's refusal to address valid concerns brought to her office.

Good afternoon, Chair San Buenaventura, Vice Chair Aquino and Senate Health and Human Services Committee Members,

I am an independent Domestic Violence Survivor Advocate with over 30 years of experience who works (primarily) with women and their children who have "successfully escaped" domestic violence. Unfortunately, I cannot support Ms. Betts's nomination as DHS Director and would like to apologize for what I feel morally bound to inform you of here.

One of the worst by-products of domestic violence is the many betrayals the victim-survivors endure by those they once loved, or literally entrusted with their and their children's lives. This latter category includes professionals, many of whom ascend to leadership positions purporting and proclaiming themselves to be champions of the abused, who instead of doing what's right, honest and ethical by these most vulnerable throw them "under the bus" instead, most times to cover-up and conceal their own malfeasance or the wrongdoing of those under their supervision. I am sorry to inform this body that Cathy Betts falls into this category and as such, is unfit to continue serving as the Director of Hawaii's Department of Human Services.

To exemplify my assertion here, please consider the following redacted email excerpts from one of my domestic violence survivor moms below. This mom desperately sought out Ms. Betts's assistance and intervention when CWS illegally removed (without warrant or court order) her toddler from her as she tried to escape her abusive marriage with this child (as is legal for her to do under Hawaii state statute):

"I have spoken with literally every single supervisor, branch administrator, and admin person affiliated with CWS here in Hawaii everybody except for the director I've had at least one if not multiple conversations with them. Some of the higher-ranking ones would be XX, XX, XX, XX, XX, **Kathy Betts (who actually went behind DHS's back on my behalf and gave me a private referral to an attorney named XX.** He had started working on my case and unfortunately passed away only a number of days into it. I can provide emails and documentation showing that Kathy specifically talk to that man into helping me because she knew DHS was dead wrong)...."

"...before Christmas in **2018** I had been able to finally get a meeting with her **(Ms. Betts)** and the branch administrator, XX. They met with me and I voiced my concerns about XXX and all that jazz. XX kind of shrugged it off like it was something that they screwed up with all the time however **Kathy Betts kind of spoke with me more in private and told me that she was really scared for XXXX (mom's toddler)**

and that she believed everything I was saying and that she wanted to help me. Of course she only wanted to help me after learning that the ACLU was involved and currently was investigating the army for their participation in XXXX's removal. She gave me a private referral and told me not to say anything to anybody but to go and see him immediately which of course I did just to see what was going on there his name was XX. He was a high-profile well-paid attorney and was willing to do my case for peanuts. I was suspicious and thought his only interest was to gather information for Betts, so I halfway spoke to him kind of but didn't really tell him anything and he always was asking me about ACLU. He passed away about two weeks after I was introduced to him suddenly and unexpectedly. Suddenly Kathy acted like she didn't know me I got pissed off and I reported it to I can't remember who it is but it's like the office that investigates when officials make bribes and all that stuff I'll have to look up the agency but I made a complaint about it they said they were going to investigate it and I never heard back."

"Do you see because after I taking up a bunch of issues with the deputy attorney general, XX, (I chose to reach out to him specifically because he was in charge of the Justice Department and he was in charge of HPD so I was trying to bring my concerns to him in order for him to address the illegal removal which he refused to address)... Mr. XX even called over and spoke to Kathy a number of times and was in close contact with my Victim Witness Advocate, XX, with the Kokua program. While at the same time I had XX the woman that you met who used to work with the NCADV also calling over and talking to Kathy. Most of this stuff took place in December or early January as I was desperate to find help to try and at least make sure that somebody held them accountable just in case they killed XXXX (the toddler). I was frantic calling all over the city pregnant with (her 2nd child) being harassed by XX it was a nightmare."

Although I contacted Ms. Betts and her office directly, multiple times and in CC'd communications about this case and others throughout her tenure, <u>I don't have a single letter</u>, <u>email or words from her of my own to share with you because she has been wholly</u> <u>unresponsive to me</u>. If you had a subject matter expert willing, ready and able to assist you on a case where you feared for a toddler's life, wouldn't you want to consult with that person or at bare minimum, hear her or him out?

To be clear, Ms. Betts cannot misuse client or "case confidentiality" as an excuse to not respond or to not communicate with me because I specifically identified wanting to speak with her about *problems* involving **falsified documents**, **documentation and reports being made to HPD, medical professionals** <u>and the court</u> to induce reaction, perjury, **fraud and crimes against children and families** <u>by CWS social workers AND</u> <u>supervisors under her management</u> which I asserted was an *ongoing problem* with DHS/CWS.

The lives of mothers and children, who were already in a precarious position due to domestic violence then subsequently entangled in the CWS system (in many instances at their abuser's instigation) have been left effectively ruined, courtesy of Ms. Betts's failure to act and looking the other way. Over the past *several years*, Ms. Betts has had the power and authority to change her modus operandi and intervene but at every opportunity, has elected not to do so by remaining unresponsive.

Ms. Bett's character as illustrated in the above email excerpts is *not* what the people of Hawaii need or deserve to have seated at the head of the DHS with oversight of our islands' most atrisk populations. (And may I also ask you to consider the amount of taxpayer dollars that funded the play-act that Ms. Betts and her colleagues put on in pretending to take my client seriously? Because in absence of correction, that's what our taxpayer dollars are funding.)

Ms. Betts has been in her position since 2020 and was DHS Deputy Director since 2017 – *ample* time to address & correct any of the myriad of problems occurring under her watch at DHS which have only gotten worse and are coming more to light, thanks to the efforts of the Hawaii Coalition for Child Protective Reform, true journalists like John Hill of Honolulu Civil Beat and citizens who have absolutely had enough of DHS scandals and missing, dead, abused and/or traumatized children being illegally removed from their homes in violation of their 4th Amendment rights, case-in-point being the Ariel Sellers/Isabella Kalua case.

In that case (which would have never occurred if the Department were sufficiently trained on domestic violence and had followed proper placement protocol) the Department, *who is inpart responsible* for Ariel's disappearance and presumed demise, in response proposed (another) working group comprised of people/organizations of *their choosing* (with domestic violence representation noticeably absent, despite testimony recommending inclusion, even in HB1365 HD1 form) and asked for more funding - *that's* their "corrective action" for what happened to Ariel?! If your child were killed under CWS watch, giving more taxpayer money to the accomplices and authorizing a "Malama Ohana" working group would be sufficient for you? **This Legislature should be launching an investigation into Ms. Betts's actions and inactions pertaining to DHS malfeasance under her tenure and be demanding accountability** rather than rewarding her with the title, position and power to do more harm through neglect to Hawaii's most in-need.

Please know that it brings me no pleasure in having to submit this testimony to you, but remaining silent about what I've witnessed and experienced would be an injustice to the people I'm committed to serving.

If you sincerely care about ending familial abuse in our communities, then I urge you to find a candidate worthy to assume such a critically important role that serves our state's most at-risk victims, survivors, children, families, elderly, impaired and disabled in an honest, forthright and responsive manner. Hawaii is gifted with *many* talented, caring and committed professionals, qualified and capable of leading such a charge – please announce a search to find one of those to fulfill the DHS Director position.
