Aloha Chair San Buenaventura:

My name is Kenny Fink, and I am Governor Green's nominee to be the Director of Health. As a seasoned physician executive, I have expertise in medicine and public health, knowledge of healthy policy having worked at the State and federal levels, and experience as an administrator and leader. I am interested in serving as the Director of Health because I believe in the value and meaning of public service, and I embrace the Department's mission to promote and protect the physical, behavioral, and environmental health for the people of Hawai'i. I recall I wrote in my medical school application personal statement that I wanted to help people be healthy to be able to do the things they enjoy. During my medical training, I became more interested in population and public health, and health policy in general. I believe government is important for keeping the public safe and providing a safety net. For most of my career, I have worked in the public sector finding meaning in service. Serving as the Director of Health would provide an opportunity for me to have a significant impact on the health of my community. I provide responses to your questions below, and I humbly ask for your recommendation to advise and consent to my nomination.

#### (1) A description of your experience in the field of Health, or any related field;

I have subject matter expertise in population health and public health. After earning Medical Doctor and Master of Governmental Administration degrees from the University of Pennsylvania, I completed a residency in family medicine at the University of Washington. I then went to the University of North Carolina at Chapel Hill where I earned a Master of Public Health degree, completed a preventive medicine residency, and completed a health services research fellowship as a Robert Wood Johnson Clinical Scholar. My good fortune continued as I was selected to be a Kerr White Visiting Scholar completing a health policy fellowship at the US Department of Health and Human Services Agency for Healthcare Research and Quality (AHRQ). I have an active unrestricted medical license in Hawai'i, and I am board certified in both family medicine and also general preventive medicine and public health. I have been

awarded the degree of fellow by both the American Academy of Family Physicians (AAFP) and the American College of Preventive Medicine.

I have substantial experience in evidence-based health policy. At AHRQ, I directed the US Preventive Services Task Force program whose recommendations are arguably considered the goldstandard in clinical prevention and are required to be covered under the Affordable Care Act (ACA). As the Evidence-based Practice Centers program director also at AHRQ, I collaborated with federal agencies, national professional organizations and others to develop systematic reviews for clinical guideline, quality indicator, coverage decision, and research agenda development. At the Centers for Medicare & Medicaid Services, I served as the Chief Medical Officer for Region 10 performing outreach and education to the clinical communities and leading quality improvement initiatives, and I also served as a clinical expert to the Office of the Inspector General. I have published research in top-tier peer-reviewed journals and served on the editorial board for the Journal of the American Board of Family Medicine for over a decade. Recently I served a four-year term on the AAFP Commission on Health of the Public and Science.

I have a proven track record of leading healthcare organizations. As the Hawai'i State Medicaid Director, I led a complex \$2.0 billion program providing health insurance to nearly one-fourth of the residents in Hawai'i, including overall responsibility for budgeting and finance, contractual oversight, customer service, compliance with state and federal law, systems, personnel, and external affairs with healthcare providers, advocates, and legislators. During the great recession, I managed a \$100 million general fund budget reduction, led staff through a significant reduction in force while experiencing a 35% increase in beneficiaries, and led implementation of provisions under the ACA, the biggest changes to Medicaid since its inception. Under my leadership, Hawai'i was ranked by the Commonwealth Fund as the best state in the nation for healthcare system for low-income individuals.

I have also worked in the non-profit and private sectors. As the Medical Director for Kamehameha Schools—the largest independent school system in the nation that serves approximately 10,000 students of Native Hawaiian ancestry annually at three K-12 campuses, 29 preschools, and numerous community programs throughout the state, I created and led an enterprise division comprised of Health Services, Behavioral Health, Athletic Healthcare, and Student Safety departments establishing standardization of policies and procedures to mālama na haumāna. And during my recent time at HMSA, I oversaw the Medicare and Medicaid lines of business. My experiences outside of government have been humbling as I learned more about different perspectives and the need for relationships, to listen, and to partner.

#### (2) An assessment of your strengths and weaknesses;

I believe my strengths can be my weaknesses, and my weaknesses can be my strengths. What I believe is important is that I have the insight to recognize them. I'm also cognizant that I have one perspective, so not only is the team I have important, but more so that I create an environment in which they not only feel safe but feel expected to speak their minds including

and especially if they disagree with me. My belief is as a leadership team we complement each other, and our collective strengths outweigh our collective weaknesses.

I am an introvert, like off the chart on Myers-Briggs. Too often people may make incorrect assumptions confusing supercilious with shy. I recognize that I have to make an intentional effort to attend gatherings, socialize, and develop relationships. But as an introvert, I try to avoid attention, so it's easier to give credit and be humble. I also prefer to listen than talk, which helps me focus beyond the words on the meaning and intent of what's being said.

I suppose I could be considered a scientist. I seek to base my decisions on the best information available trying to optimize the desired health outcome. My recommendations for evidence-based policy are generally sound. But I do not have a natural political acumen. I would like to believe that good policy is good politics, but I recognize that policy is determined through a political process. I understand that while I may be recommending policy based on my touching one part of the elephant, stakeholders may be touching other parts. Communication is important to have a more informed process and recognize that indeed we're talking about the same elephant. And while I may recommend the best policy for protecting public health, there may be other secondary impacts that need to be considered. The Director of Health should be the strongest advocate for the health of the public, but should also recognize when ideal is not achievable, and some improvement in health is better than no improvement.

I've had a breadth of experiences including state and federal government, non-profit, private sector, and military. The amalgam may obfuscate an archetype, but I will be predictably guided by the Department's mission, vision, and values. My perspective could bring positive change and some innovation. However, if the expectation is that because I previously worked for the State, I am more likely to follow the status quo, then the dis-synchronicity between expected and actual could cause consternation and have a negative impact. Effective change management is important and starts and ends with communication.

I am dedicated to my family, and I couldn't pursue this opportunity without their support. They are the ones who will be there for me when I falter. They are my source of strength. And as they sacrificed during my military services, they would sacrifice again during this public service. I understand that at times, and perhaps frequently, I will need to prioritize work, but I will strive to maintain balance and protect some family time when I can truly be present with them. My record demonstrates my high work ethic that I don't believe is incompatible with this.

# (3) An assessment of the department's strengths and weaknesses. Please include an explanation of how the department's strengths may be best utilized, as well as how the department's weaknesses may be improved;

In 2002, McGinnis et al published the sentinel manuscript on the determinants of health (<u>https://www.healthaffairs.org/doi/10.1377/hlthaff.21.2.78</u>). Health behaviors, genetic predisposition, environment, and healthcare contributed 40%, 30%, 20%, and 10% respectively to health status. And while healthcare contributed only 10%, 90% of the total expenditures for

all categories combined were spent on it. In their model, environment contributed 20%, including 5% for things such as air and water, and 15% for social environment, including food and housing, poverty, and race and ethnicity.

Healthcare, population health, and public health are a continuum, and investing more in public health can improve health status and reduce healthcare expenditures. The Department is ready should there be a desire to substantially invest in public health. For example, there continues to be an increasing prevalence of end stage renal disease (ESRD) with a response to have more dialysis facilities. However, there hasn't been a concurrent investment in preventing and managing hypertension and diabetes to reduce the incidence of ESRD. Intervening upstream in a disease process continues to be increasingly important.

Public health can be challenged with long lead times, perceived small gains, and proving a negative. According to the CDC, almost one in two adults has hypertension, and of those with hypertension, only one in four has it under control

(https://www.cdc.gov/bloodpressure/facts.htm). It may take some time to see a reduction in the rates of stroke, heart attack, and heart failure resulting from interventions to improve the diagnosis and management of hypertension. And we might see only a small decrease. But with a large population attributable risk, a small decrease corresponds to a substantial impact. In a population based or public health intervention, we are likely unable to determine in which individual person the undesired health outcome was avoided. In addition, assurance is a core public health function such as through facility, food establishment, and other inspections, and their success is the absence of something that is hopefully a rare occurrence including nosocomial infection or food-borne outbreak. Providing education and more effectively communicating about public health might help improve understanding of and investment in it.

The Department's inability to influence policy to protect our keiki is a weakness. The Department has unsuccessfully worked for nearly a decade on getting flavored vaping products banned. I recently read an article that considered law as a social determinant of health. This could occur based on what law does or doesn't do. An example of the former could be the criminalization of possession of small amounts of cannabis and its sequelae; an example of the latter could be allowing the sale of flavored vaping products which disproportionately targets and harms our youth. Prior to the outbreak of e-cigarette or vaping use-associated lung injury (EVALI), about one in three high school students used e-cigarettes or vaped. The acute manifestation of harm and media coverage resulted in decreased use, likely confounded with the pandemic, but use is now rising again while the insidious harm persists and is overlooked. Policies to protect our youth from the inhalation of concentrated nicotine and flavoring chemicals, whose structures may change when heated and have not been evaluated for safety, have been ineffective. Being on the precipice of legalized recreational cannabis, we risk compounding harm to our youth. The Department will continue to provide evidence-based information and strive to protect our keiki.

Only about 15% of the Department's budget is general funds. While some funding is through special funds, the majority is federal funds. But federal funding is not received in a single omnibus grant; the Department must apply for numerous grants to maintain operations. Much,

if not most, of that federal funding reaches our community through contracts with local organizations. The applying for federal grants, meeting grant requirements, contracting and overseeing contracting all require substantial administrative support. A challenge of ours is not having enough staff to do this work and subsequently needing to forego some federal funding opportunities.

Another strength and weakness is our workforce. As I've been meeting with staff, and am continuing to do so, I have been impressed by their expertise and dedication. They are without a doubt a strength. The weakness is not having enough of them. Customer service, such as for vital records requests and permits, may be where our workforce shortage is most apparent by causing delays, but there are other impacts as well. While we seek to address the workforce shortage, we are also pursuing business process, workflow, and system changes, as applicable, to improve efficiency. I address in my response to question (6) how we are trying to address the workforce shortage.

#### (4) An overall vision for the department, specifically what goals can be accomplished within the next four years and what types of annual benchmarks can be used to evaluate the department's progress towards those goals;

The Department's vision is that all Hawai'i residents have a fair and just opportunity to achieve optimal health and well-being. Our mission is to promote and protect the physical, psychological, and environment health of the people of Hawai'i through assessment, policy development, and assurance. Our values are Integrity, Stewardship, Science, Curiosity, Innovation, and Communication.

My top priority is not what we do, but rather how we do it. A strong foundation is the necessary platform to optimize efficiency and effectiveness. With 3,300 positions and about 850 vacancies, we need to look at how to work differently. Caring for and engaging the workforce is the first and most important step. They will be the ones to generate the best ideas; my role is to create an environment conducive for this to occur.

I believe the pandemic revealed the erosion that had occurred in the public health infrastructure and workforce, and it reminded us that we need public health when we need it. If neglected, public health won't be ready when needed to respond. With added responsibilities, the public health workforce needs to grow. Setting a position cap means that responding to a new issue, such as increased mental health needs, must come at the expense of other public health functions. Our public health workforce is our most valuable asset.

The pandemic was a moment for public health to shine, and in many ways it did. But, there were certainly bumps along the way. It was a highly dynamic time with an explosion of new knowledge resulted in changing guidance as more was learned. While there may have been opportunities for communication improvement, the politicization of science trumped and triumphed. With a plethora of misinformation and disinformation, deciphering accurate information became increasingly difficult with traditionally trusted sources increasingly

dismissed. Respecting that individuals will make their own decisions, my goal is for the Department to be a trusted source of information to inform those decisions.

Increasing health literacy will help improve the provision of more understandable information and the community's ability to understand it. According to the Health Resources and Services Administration, personal health literacy is the degree to which individuals have the ability to find, understand, and use information and services to inform health-related decisions and actions for themselves and others; and organizational health literacy is the degree to which organizations equitably enable individuals to find, understand, and use information and services to inform health-related decisions and actions for themselves and others (https://www.hrsa.gov/about/organization/bureaus/ohe/healthliteracy#:~:text=Personal%20health%20literacy%20is%20the,actions%20for%20themselves%2 0and%20others). Providing information this is accurate, accessible, and actionable is an

important part of health literacy and helps with becoming a trusted source. Building out the communications office is essential for this.

To be a trusted source, we need to say what we know and what we don't know. We will make mistakes, and we need to be transparent about them and explain what we learned and how we'll correct. Building trust means having a relationship. Engaging with communities, especially disenfranchised ones, for purposes of listening to and addressing their concerns, rather than solely in advancement of what we believe to be their interests, is important. Public health requires engagement with the public, and we need the workforce to be able to so do.

Disenfranchised communities tend to have higher rates of health disparities. Although Hawai'i has the longest average lifespan compared to all other states, this masks the ten-year variation between those who for example live at opposite ends of H-1. While the difference is multifactorial, it represents an inequity. Directing resources and effort to the populations with the greatest need is part of health equity. Embodied in the Department's vision is health equity.

As the virus that causes COVID-19 transitions from pandemic to endemic and federal funding subsides that was available under the Coronavirus Aid, Relief, and Economic Security Act (CARES Act), American Rescue Plan Act, and the Inflation Reduction Act, the Department needs to ensure we optimize this opportunity and are in a better place as a result of it. Some examples of investment include improved data infrastructure and new equipment and capability for the State Laboratory. We need to identify and anticipate which federally funded activities to sunset and for which programs and positions to pursue supplanting general funds.

As a tactical level, there are certain issues facing us now that are both urgent and important. We must ensure the defueling of Red Hill as quickly as can safely be performed. We must hold the Department of Defense (DoD) accountable to a timeline that is acceptable to the Department. With the expertise and resources at DoD's disposal, anything other than an expeditious timeline with clear dates that is communicated to the public would suggest a lack of concern for the people of Hawai'i and our natural resources. Once defueled (and aqueous firefighting foam removed), the threat of further imminent contamination of the aquifer is abated. The decommissioning process would then ensue while aquifer remediation is ongoing.

Water safety and quality will remain prominent as there is increased detection of per-and polyfluoroalkyl substances (PFAS) in our drinking water, and we will continue our work on cesspool conversion.

Community mental health has deteriorated, and there is a need for increased community mental health services. With the Hawai'i State Hospital (HSH) having around its highest census, we need to implement measures to ensure that only those who require that level of care receive it. Access to earlier treatment, diversion programs, expanding community resources, and increased transitional options are all aspects of the comprehensive mental health system that is needed. And we'll need to look more closely at HSH itself to ensure the safety of staff and patients.

Following the unauthorized access of our Electronic Death Registry System (EDRS), we will continue implementation of additional security measures. We are also conducting a security review of all our systems.

We are aware of the delay in issuing birth, death, and marriage certificates. Clients need these documents and deserve timely issuance. We have focused on this and made improvements, and we will continue to make further improvements to our operations and system to provide more timely issuances.

Routine early childhood immunization rates have declined nationally, including in Hawai`i and there has already been a measles outbreak on the mainland. During the 2019-2020 school year, 3.4% of schoolchildren had missed routine vaccinations or had incomplete immunization records. This figure jumped fivefold this school year to 18.6%. And religious exemptions increased by 50%. Six states including California, Kentucky, and Mississippi, but not including Hawai`i, do not allow non-medical exemptions. We will work to increase vaccination rates, and we will pursue enhancing our vaccination registry to assist both healthcare providers and the Department of Education.

The unfortunate air ambulance incident revealed the vulnerability of air ambulance services for people in Hawai'i. We believe that ensuring access to both air ambulance services, like we do for ground ambulance, is critical. As such, we presented options to the legislature for a policy decision that would require an appropriation.

The Department's strategic plan has not been updated since 2018. Updating the plan, with public input, should occur.

In summary, some specific goals and benchmarks include:

- Plan for federal funding reduction following end of the public health emergency
  - Captured in biennium and supplemental budget requests
- Defuel and decommission Red Hill
  - Defueling completed by the end of calendar year 2023
  - Accepted decommissioning plan by end of April 2024
  - Decommissioning completed by end of September 2024

- Open a Certified Community Behavioral Health Center (CCBHC) in every county
   Two CCBHCs by end of June 2024
  - Two additional CCBHCs by end of June 2025
- Expand mental health crisis/stabilization beds
  - Add 16 new beds on Oahu by end of calendar year 2023
- Improve timeliness of vital record certificate issuance
  - Reduce delay to one month by end of May 2023
  - Reduce delay to two weeks by end of August 2023
- Increase vaccination rates for children 19-35 months of age for 4 DTaP, 3 Polio, 1 MMR, 3 HIB, 3 Hep B, 1 Var and 4 PCV
  - Increase vaccination coverage to 65% by end of 2023 (reported in 2025)
  - Increase vaccination coverage to 70% by end of 2024 (reported in 2026)
- Improve the stability and predictability of inter-island air ambulance services

   Implement an option by end of March 2024
- Update the Department's strategic plan
  - $\circ$  Draft plan by end of 2024
  - Final plan by end of June 2025

#### (5) The department's top budgetary priority for the biennium;

The Department has numerous priorities. In general, the top priority is growing the public health workforce. We are seeking to expand the capacity and capability of the District Health Offices on the neighbor islands, staff a CCBHC in every county to better address urgent mental health needs, increase staffing at the Hawai`i State Hospital to increase quality and safety of care, establish an environment health planning office to address health impacts from climate change, increase the Human Resources Office to improve recruitment and hiring, and increase the communication's office to improve dissemination of information. With the federal health equity grant concluding, we are also seeking to make those positions permanent.

Our hope is that we don't have to cut other positions to get these new ones that are sought to address new needs. While we have a substantial number of vacancies, some work isn't being done and other work is being contracted; we still need those vacant positions. As we reassess, we should identify work that may no longer be needed and intentionally eliminate the positions for that work. Note that of our approximately 850 vacancies, about 300 are in behavioral health, and the other 550 are distributed over roughly 70 branches, offices, and divisions.

# (6) An assessment of the department's staff morale, including the turnover rate for personnel; and

As a general matter, staff are mission-driven. During the pandemic, they sprinted a marathon. They were tired and burnt-out. In my opinion, they were, and are, the hidden heroes. The effrontery surrounding the pandemic response should in no way minimize their diligent efforts to help protect our community. They deserve the mahalo they never received. The pandemic response experience likely traumatized many staff. This preceded me, but I believe they supported one another the best they could. Not that I think staff are seeking accolades, but I imagine that given staff's long hours and personal sacrifice for the betterment of their community, having the community challenge their intentions or merit of their work could be disheartening. Staff are recovering and at different rates, and I think it's important for me to recognize and acknowledge that.

With the convergence of departmental leadership change and pandemic waning, there seemed to be a higher rate of resignations and retirements, which appears to have since returned to baseline. But I am concerned that the persistent workforce shortage adds sustained stress. We simply cannot continue to ask staff to do more with less. Delays in hiring hurt morale, and having vacancies eliminated really hurts morale.

So, we're trying to do what we can. We've received approval for more delegated hiring, have requested additional recruiter positions and funding for recruitment activities, and are exploring university partnerships as well as internships. We need to generate interest in public health careers, develop a pipeline, and have a streamlined hiring process. In a 2021 article on public health graduates and employment in government public health, the pace of the hiring process, ease of navigating the job application/hiring process, and communication from the employer after submitting the application were perceived to be negative influences on the decision to take or continue pursuing a job in governmental public health

(https://journals.lww.com/jphmp/Abstract/2021/01000/Public\_Health\_Graduates\_and\_Employ ment\_in.2.aspx).

My job is to care for my staff, and I espouse a servant leader approach to leadership. I believe that rather than my staff working for me, I work for them, and they work for the public. By creating an environment that is safe and supportive, putting staff in positions to be successful, and coaching instead of criticizing, staff will feel valued. I know that my actions will speak more loudly than my words, and until I am able to provide staff with facilities that have consistently functioning bathrooms, ceilings that don't leak, and a sense of security walking to and from their vehicles, all I have is words. I seek to have staff feel engaged and invested by delegating authority, as appropriate and with guardrails, and by having them provide meaningful input into decisions. Imagine 2,500 staff who are motivated to think of ideas for improvement and feel safe to share them. Don't expect me to have the best ideas; expect me to get the best ideas from my staff.

## (7) Any foreseeable possible conflicts of interest that could arise during your service in the department and how you would overcome them.

To avoid potential conflicts of interest, I have resigned from the boards of the YMCA of Honolulu and Institute for Human Services. Also, to avoid potential conflict and my being over-extended, I resigned from the US Air Force after twenty-three good years in the Air Reserve Component. I have found my military experience to be a surprising asset in working with federal partners both with regard to emergency preparedness and to the Red Hill response.

Having worked recently at Hawaii Medical Service Association (HMSA) for about one and a half years and expecting to receive a bonus this spring for work performed last calendar year, any decisions I make that directly impact HMSA could be perceived to have a conflict. I am unaware of any current contracts with HMSA and the Department does not regulate health plans. However, should a matter arise, I anticipate that I would defer to a Deputy to handle.

I am also grateful for the opportunity to have worked at Kamehameha Schools. While there, I developed a greater knowledge, understanding, and appreciation for Native Hawaiian culture and history. That experience may cause me to have a greater sensitivity and interest in Native Hawaiian health. However, I don't foresee any potential financial conflicts.

In 2015, while otherwise unemployed, I established a consulting business, Invictus Consulting. I have not done any work or received any revenue under this business for more than two years. For at least two years preceding that, my only client was the State of Hawai'i. I served as the expert witness for the State in a lawsuit that resulted in a settlement with the defendant paying the State approximately \$13 million. Given the effort to establish the consulting business, I intend to keep it in existence and good standing. However, I commit to not doing any work under this business while serving as the Director of Health, should I be confirmed.

Mahalo for the opportunity to share my thoughts, and I look forward to answering any questions you may have. I humbly ask for your recommendation to advise and consent to my nomination to be the Director of Health.
