Re: Governor's Message 524 – Nomination of Kali Watson, DHHL

Responses to Questions:

(1) A description of your experience with respect to the scope of responsibilities for DHHL and the Commission, or any related field;

I served as the head of DHHL and the Commission from 1995 to 1998 under Governor Ben Cayetano State Administration. Prior to that, as State Deputy Attorney General from 1979 to 1984, I was assigned to DHHL and oversaw the commercial and industrial properties. On occasion I was asked for legal opinions or advice regarding the Hawaiian Homes Commission Act, HRS and case law.

(2) An assessment of your strengths and weaknesses;

My strengths are based on my experience having headed up DHHL, continuing to support the program through my nonprofit Hawaiian Community Development Board and twenty years of private development experience. My weaknesses would be not being well versed in all the current problems, programs and DHHL and wait list beneficiary demands.

(3) An assessment of the department's strengths and weaknesses. Please include an explanation of how the department's strengths may be best utilized, as well as how the department's weaknesses may be improved;

The department's strengths lay in its land base and statutory entitlements derived from our State Constitution, HRS and case law. It also lay in Act 279 funding, along with other available funding. It may be best utilized by aggressively pursuing development of the 20 projects identified in the Strategic Plan and approved by the Hawaiian Home Lands Commission. Leveraging the funds is going to be key to expanding the unit counts. Another strength, as was done in Nanakuli to develop the Nanakuli Village Center, are the beneficiaries themselves and their homestead associations that have long been organized and knowledgeable about their respective regions and issues on the ground in community. I plan to work with the various organizations to move their plans forward.

The department's weaknesses revolve around its' lack of capacity. It needs more staff, but staff with various expertise and experience to move the program forward. It needs better technology to improve the communication with its wait listers and existing homesteaders. It needs to work better with all the pertinent government agencies, service providers, financial institutions, and developers.

<u>Senior VP</u> Patti Barbee (4) An overall vision for the department, specifically what goals can be accomplished within the next four years and what types of annual benchmarks can be used to evaluate the department/agency's progress towards those goals;

My vision for the department moving forward is to facilitate a massive infusion of housing throughout the State with the ancillary services and improvements provided by the Alii Trusts and OHA. This collective effort will invigorate and make the homesteading communities a place where its beneficiaries want to be - a place where the beneficiaries can raise their families in a healthy, economically vibrant, educationally and culturally active community – a place where the beneficiaries can feel secure, work, play and look forward to a bright future.

For the next four years, an annual and simple benchmark would be the number of lots issued by DHHL, and the number of homes built by DHHL's developer partners, homesteaders themselves and Habitat for Humanity or self-help entities. Another benchmark will be what the Hawaiian Trusts do in the homesteads.

(5) The department's top budgetary priority for the biennium;

The top budgetary priority is obtaining "sufficient funds" under Article XII of our State Constitution. There are four purposes listed with budgetary amounts identified. I am tasked with justifying the requested amounts, which I will do. This budget was prepared by the past administration and I need to show the adjustments that are warranted and consistent with my goals of moving the program forward. Homestead Lot Development which is Purpose 1, is obviously a priority since funding is for development of 773 lots that were previously awarded and not covered by the Act 279 money. Homestead Loans is Purpose 2, which my priority would be for a pilot allocation to fund and open the first farming and ranching loan program. Rehabilitation Programs is Purpose 3, which my priority is to provide funding to the various homestead associations for kupuna and rental housing projects. Operating/Administrative Costs which is Purpose 4, is another top priority because it provides the personnel and professional service funds needed to implement my major initiatives overall and in Act 279, which the Legislature has tasked the Department to accomplish within three years.

(6) An assessment of the department staff's morale, including the turnover rate for personnel; and

It needs a boost. There are not enough people in place and the ones working are exhausted. There has been minimal turnover, but the bigger issue is the vacancies and need for overall increase staffing to efficiently use the Act 279 funds.

(7) Any foreseeable possible conflicts of interest that could arise during your service in the department and how you would overcome them.

My nonprofit Hawaiian Community Development Board has done several projects on DHHL lands over the years. For example, HCDB is currently doing the Ulu Ke Kukui renovation project with NAHASDA funds from DHHL. Therefore, any actions involving any of HCDB projects, including oversight by DHHL, will be independently monitored. I will also recuse myself from any needed action by the Commission.

Aloha, Chair Shimabukuro, Vice Chair Fevella. Thank you for the opportunity to present testimony on the confirmation of Kali Watson.

Chair of Hawaiian Home Lands and Director of the Department is a tough, tough job. Kali Watson is an excellent candidate to guide the department at this point in its history. There is no time to quibble with this choice.

To become a truly effective director of any of the State departments takes one to two years in the best of circumstances. Directors have to totally understand and internalize the mission and practices of the Department; they have to appreciate the complexities of the Federal, State and County laws that govern their work; they have to get to know the affected public for whom the department works and, equally important, they have to be able to direct all the little things that make a department function: understand how to manage at least 200 employees stretched over all islands of the State, negotiate with unions, write budgets, appreciate the processes and people of all the other departments with which they have to work. Ask any department head, new to the job; one year, maybe two is absolutely necessary to be effective.

The next chair of Hawaiian Homes does not have two years to understand the job. By the end of two years, the next Chair has to encumber \$600 million. In the best of times, even with a superior well-oiled staff and no distractions, that job is nearly impossible. These aren't the best of times. There are key vacancies in the Department that have to be filled; there are multiple other goals that will distract the Director's attention; the beneficiaries' and the public's expectations are high. The next Director absolutely has to understand this job from day one. Kali Watson is one of a very small handful of people with the experience and skills to effectively do it.

I worked side by side with Kali for four years when he led the department from 1994 to 1998. He knows the job. More important, he's smart and he's tough. If he accepts the job, he won't back down from accomplishing the task you lay before him. He inspires good work. He knows how to lead.

When Kali's term ended in 1998, he dedicated his life to working with the native Hawaiian community in both the development of affordable housing and in the development of economic investments that serve the community. His commitment to the native Hawaiian community did not end with the end of his term as Chair. I expect Kali could have made much more money and enjoyed a quieter life as an attorney in the business world, but that's not where his heart resides. His heart is right here, in the homestead communities.

Able, knowledgeable of the task, committed, ready. Kali Watson is a solid choice and I urge your confirmation of him as the next Chairman of the Commission and Director of the Department.

Good afternoon Senator Shimabukuro and members of the Senate Committee on Hawaiian Affairs. My name is Patti Tancayo Barbee, Senior Vice President of Hawaiian Community Development Board. I strongly support Kali Watson as the Director of the Department of Hawaiian Home Lands and Chairman of the Hawaiian Home Lands Commission.

Kali exceeds the qualifications for this position. Kali is a visionary that will bring experience, knowledge, and passion to this vital role. He understands the department's challenges, has a demonstrated track record of finding solutions, and has already returned thousands of native Hawaiians to the homeland. From a Hawaiian lawyer fighting for native rights to a past DHHL Director to an affordable housing developer, there is no other person better for the job. I am grateful that he accepted Governor Green's nomination.

I speak from a unique perspective and understand what qualifications are needed to be the leader of Hawaiian Home Lands. First of all, I am a beneficiary. I grew up on Hawaiian Home Lands in Ho'olehua, Molokai, and am on the waitlist. I understand how it feels to be waiting on the list for 30 years. I know how having Uncles and Aunties die on the list feels. Second, I have worked in the affordable housing field for over 30 years. I created a 100-million-dollar program with Fannie Mae. I conducted self-help projects, helped create Habitat for Humanity projects, and developed single-family homes on Hawaiian Home Lands. Today, with Kali at Hawaiian Community Development Board, we have developed the Nanakuli Village Commercial Center and Hale Makana O Nanakuli Affordable Rental Project on Hawaiian Home Lands, completed over 500 affordable housing units off of Hawaiian Home Lands, and have another 500 units are in escrow on Oahu, Kauai, and Maui. Hawaiian Community Development Board is one of the state's top non-profit developers.

I've known Kali for over 25 years. He has integrity and a sincere desire to help the poorest Hawaiian families. I first met in 2000, when I worked at the Office of Hawaiian Affairs as its Housing Specialist. He approached my desk and said, "I'm starting a non-profit that will focus on building affordable housing on Hawaiian Homelands. The first project I want to do is replace dilapidated houses." Then he handed me a report of all the houses ready to fall down but still had people living in them. I paused and said, "Do you know how difficult a project like this will be? These families probably have severe economic, social, and health problems." He said, "Yes, and that's why I want to do it. We need to help the neediest Hawaiian families first."

So, Kali and I rolled up our sleeves, dove into the trenches, and created our first project, Kauhalepono Home Replacement Project. We sent letters to every homesteader on Oahu and received hundreds of responses. We worked with hundreds of families, one on one. We helped families get jobs. We helped them repair their credit. We helped them get their GED. We helped them get dentures. We helped them apply for financing, get qualified for a construction loan and mortgage, helped them select a contractor, helped them get insurance, helped with temporary living arrangements, plus provided downpayments. We helped about 23 families in all, which took about 4 or 5 years. If anyone thinks that Hawaiian Community Development Board used grant monies set aside for some of the poorest homesteaders in Hawaii inappropriately, you are mistaken.

I am genuinely excited for the future of the native Hawaiian community with Kali at the helm at DHHL. Start ordering the o'o sticks. Thank you for the opportunity to testify.

Where are now after all these years? As of 2020, there were only 575 acres (2650-2950 lots) available for residential homesteads on O'ahu the island with the most needs for our cultural restoration. 160 acres in Kapolei, 300 acres in Nanakuli, and 48 acres in Nanakuli.

According to the article listed below "as 2020 draws to a close, Native Hawaiians are still waiting for all of what was promised. The department has developed just 3,300 residential lots statewide since 1995, even as its residential waitlist has ballooned to 23,000". To note 1995-1998 was under the watch of Kali Watson.

"While the state has added nearly 16,000 acres to the land trust, just a fraction were on Oahu, the island with the greatest housing demand. The state still owes another 1,300 acres to the Department of Hawaiian Home Lands under the terms of its reparations bill, known as Act 14, an investigation by the Honolulu Star-Advertiser and ProPublica has found." The Government Promised to Return Ancestral Hawaiian Land, Then Never Finished the Job — ProPublica

Our philosophy supports affordable housing, culturally-relevant financial education, and asset building and community lending programs to realize our mission. Since our founding in 2000, we have served over 23,000 individuals with free financial education and assisted more than 9,000 children and adults in successfully obtaining rentals, purchasing homes, or preventing foreclosure and eviction.

Our organizations have worked closely with Kali and his nonprofit, Hawaiian Community Development Board (HCDB), for over the last decade. We have assisted Hawaiian and non-Hawaiian families in becoming financially qualified for thousands of rental housing units and forsale homes developed by the nonprofit. It is through this partnership that we have seen Kali and HCDB lead developments, establish partnerships, and leverage millions of dollars in public and private capital to build homes that are housing our local and Hawaiian people, affordably.

In 2012-13, we assisted with applications and qualifications for more than 250 families interested in the Hale Makana 'O Nanakuli rental housing project, the only such development of its kind on Hawaiian Home Lands. Today, families earning as little as \$25,000 annually call Hale Makana home, paying no more than 30% of their monthly income toward rent. The project has been identified as a best practice not only for its ability to leverage multiple sources of capital to reach affordability for households below 30% area median income, but also for its unique ownership structure in which the Nanakuli Homestead Association owns the property as a native Hawaiian beneficiary organization.

In 2015-16, our organizations worked with Kali and HCDB to create an accessory dwelling unit (ADU) program that supports homeowners and families in helping address the housing crisis in the City and County of Honolulu. Kali's involvement assisted in bringing together key partners from G70 to Honsador Lumber to Office of Hawaiian Affairs alongside our organizations and Hawaii Appleseed to implement the program. Kali led the effort to ensure the development of ADUs as an allowable activity on Hawaiian Home Lands, which has since influenced the department's promulgation of rules for secondary dwelling units.

In 2017, our organizations assisted 69 native Hawaiian families in exercising their option to purchase rentals at the Ho'olimalima project in Kapolei. This was the first rent-with-option-to-purchase project in the State of Hawaii and was envisioned and led by Kali when he was Chairperson of the Department of Hawaiian Home Lands. The project has received national attention from the National Association of Home Builders and families purchased the homes for less than \$77,000. This rent-with-option-to-purchase development approach has since been replicated on Hawaiian Home Lands and is being looked at by counties as a viable vehicle to assist families, who would normally be unable to qualify for a mortgage, to realize the dream of homeownership.

Most recently, our organizations have worked with Kali and HCDB to support the development of hundreds of affordable rental housing units in Maui County that will serve households at or below 60% area median income, including persons with disabilities, kupuna, and families.
