Aloha Chair Shimabukuro, Vice Chair Fevella, and Members of the Senate Committee on Hawaiian Affairs,

Thank you for the opportunity to respond to the Committee's questionnaire. Please find my responses below:

1) A description of your experience with respect to the scope of responsibilities for the Department of Hawaiian Homelands and the Hawaiian Homes Commission, or any related field;

I represented the Department of Hawaiian Home Lands as a deputy attorney general for approximately eight years. During that time, I became very familiar with the Hawaiian Homes Commission Act of 1920, as amended, and DHHL's administrative rules. I also became familiar with the case law that developed around the HHCA program.

In addition to advising the DHHL Chair and staff on a variety of issues, I also served as counsel to the Hawaiian Home Commission, which meant offering ad hoc advice on sunshine law and parliamentary procedure during the Commission's regular meetings.

In the private sector prior to joining the Department of the Attorney General, my practice focused on collections/foreclosure law and planned community association and condominium law. This experience formed a strong basis in the understanding of statutory, contractual, and real property legal concepts, which I believe was a good foundation given the types of legal issues DHHL encounters.

#### 2) An assessment of your strengths and weaknesses;

My main strength is in my ability to problem solve when an issue arises – i.e., identifying the issue, which often includes having to learn about what happened quickly, coordinating among the staff who would be the most knowledgeable on the topic, and providing direction toward next steps and/or resolution. Since becoming Deputy to the Chair, this has been a skill that I have exercised repeatedly on a range of issues.

My weaknesses include not having met many of DHHL's waitlist and homestead beneficiary associations. I hope to have the opportunity to meet them with Chair Watson, and to form relationships that will help to facilitate better communication between DHHL and the communities DHHL serves. Also, while I have a good understanding of certain DHHL processes due to my work as DAG, there is much I do not know from a purely operational or programmatic (rather than legal) perspective. For example, how a departmental budget is put together, or being a manager in a large organization. I am looking forward to the opportunity to learn these new areas and skills as part of DHHL's leadership team.

3) An assessment of the department's strength and weaknesses. Please include an explanation of how the department's strengths may be best utilized, as well as how the department's weaknesses may be improved;

The strength of the department lies in the dedicated staff who have worked diligently, some for decades, in service of the Trust. It is also a strength that the State constitution recognizes the importance of the HHCA, such that DHHL should be sufficiently funded so that it can meet its mission not only to provide homestead lots to native Hawaiians, but also provide for loans, rehabilitation programs, and operating/administrative costs.

The weakness of the department is in not being able to implement initiatives quickly or process routine matters efficiently, due to the lack of capacity. While DHHL has capable staff, many have been covering additional work, sometimes in subject matter areas that they are not familiar with, due to vacancies. While filling vacancies will offer some relief, DHHL needs to also create or update internal guidelines, workflows, and tracking systems for routine matters (i.e., lease transactions, successorship requests, UIPA requests, etc.) together with the applicable law or rule or policy that is the backdrop for why the process is designed the way that it is. This would help staff who may need to step in when vacancies due to turn over happens. This would also act as a reference for DHHL to review and adjust processes accordingly when laws, rules, or policies change over time. Chair Senator Maile S. L. 4) An overall vision for the department, specifically what goals can be accomplished within the next four years and what types of annual benchmarks can be used to evaluate the department/agency's progress towards those goals;

The overall vision of DHHL should be to reduce the number of native Hawaiians waiting for a homestead. Act 279 gives DHHL the unprecedented ability to prepare lots for projects it otherwise could not have started in the next three years without such a generous appropriation. New lot development funded by Act 279 will need to be in conjunction with homestead projects already in process, as well as the repair and maintenance of existing homesteads, supported by the "sufficient sums" biennium budget.

As Deputy to the Chair, I see myself as supporting the overall vision to provide homestead lots for native Hawaiians by attempting to concurrently address how to make DHHL more timely, transparent, and responsive to its waitlist beneficiaries and homestead lessees. As DHHL prepares more lots and homes, it will need to be ready to process awards in a timely manner. It will also be responsible to an increased number of lessees who will be living on lands under its jurisdiction. DHHL thus needs to be prepared to ramp up its efforts in the administration of the important processes that impacts the daily lives of those who live in its communities maintenance issues, application and lease transfer and successorship issues, issues with compliance and safety on homestead lands, etc. My vision for DHHL in the next four years is to think though, create, and implement formal training programs, internal policies, and workflows for the various divisions to lessen the amount of gaps in DHHL's current processes that leads to uncertainty and delays.

5) The department's top budgetary priority for the biennium;

DHHL's top budgetary priority for the biennium is to determine and request the amounts it believes will sufficiently fund the four purposes outlined by Article XII, section 1 of the Hawaii State Constitution: 1) lot development; 2) loans; 3) rehabilitation projects; and 4) DHHL's administration and operating budget.

DHHL needs to be able to articulate the justification of its "sufficient sums" budget alongside its efforts to encumber Act 279 funding. While there has been an emphasis on the development of lots, both those in process (Purpose 1 of the sufficient sum budget) and for new lots (Act 279), repair and maintenance costs for existing homesteads needs to be highlighted and stressed as a priority for DHHL as well. For example, some of DHHL's older developments requires significant infrastructure investments such as for sewer upgrades. Furthermore, while sufficient sums need to increase for staffing, DHHL also needs to advocate for the resources that are necessary to manage the volume of records and information more efficiently across DHHL's divisions. This means asking for appropriations for significant upgrades to DHHL's information systems and providing training to maximize the utilization of any new system that is installed. 6) An assessment of the department's staff morale, including the turnover rate for personnel; and;

Staff morale is sensitive. DHHL is staffed with dedicated public servants who have been operating over capacity for some time and should be recognized for their efforts to manage their workloads as best as they can with reduced manpower, especially in the wake of the recent changes in administration.

7) Any foreseeable possible conflicts of interest that could arise during your service in the department and how you would overcome them.

I do not foresee any possible conflicts of interest that could arise during my service in the department. Should any conflicts arise, whether actual or perceived, I would promptly recuse myself from any decision-making or exerting any influence due to my position on the project or issue.

Aloha Senator Maile S.L Shimabukuro (Chair), Senator Kurt Fevella (Vice Chair) and other members of the committee

I oppose confirming Ms Katie Ducatt (Katie Lambert) as the Deputy to the Chairperson, Department of Hawaiian Home Lands (DHHL) for the following reasons:

- Chairperson Kali Watson is a trained lawyer and so is the DHHL Attorney General. We do not need more lawyers in the DHHL. Instead, we need experienced leader-managers who know how to develop strategies, monitor performance, improve processes and achieve results. There is no evidence of Ms. Ducatt having led or managed a midsized organization (100-999 employees) such as the DHHL at any point of her career.
- As the Deputy, she must help lead Transformation in the department to improve organizational efficiencies and effectiveness, eliminate wasteful and unnecessary bureaucracy, and improve the delivery of services to beneficiaries. Again, there's no evidence she has been trained in management programs such as Balanced Scorecard, Malcolm Baldridge Performance Excellence, or Lean Six Sigma to name a few or has any experience leading the kind of organizational changes the department needs now.
- On occasion, we expect the Deputy to step in as the Chairperson. There is no indication that Ms. Ducatt has worked with, understands or is an advocate for native Hawaiians. In fact, some in the Hawaiian Community have a dim opinion of Ms. Ducatt's adversarial role in the *State of Hawaii vs Kalima* settlement, where claim payments were subjected to "lengthy verification processes of plaintiff's lease files" (under Deputy Attorney General Katie Lambert/Ms. Ducatt's purview) which delayed action and served the interest of the State of Hawaii as opposed to native Hawaiian plaintiffs.
- Ms. Ducatt is unqualified for the position as Deputy Chairperson. She is not ready to meet the needs of the Department, its workforce and those of native Hawaiian beneficiaries now and/or future.

Aloha e Senators;

Our names are Ronald T. and Doreen K. Kodani and reside on the Island of Hawaii in the Piihonua Hawaiian Homestead Community Association. Although we are officers of this homestead association, this email we are submitting is our own opinion and testimony as husband and wife. We are not representing the Board and Members of the PHHCA.

It is with deep regret that my wife and I are in opposition to the appointment of Katie Ducatt to be the new Deputy Chair for the Department of Hawaiian Home Lands. There are a number of reasons for this opposition but will only specify 4 in this email.

First of all, it is personal to us because Ms. Ducatt was one of the lead attorneys who pursued the opposition to the Native Hawaiians' lawsuit against DHHL and the State of Hawaii in the Kalima Case. Currently, there are over 2,700 original plaintiffs in this decades-old lawsuit who were recently awarded a 328 million dollar settlement by the 2021 legislature. As we understand it, Ms. Kucatt was one of the lead lawyers who tried to dismiss this case against the State of Hawaii and the DHHL/State by the plaintiffs in this class action lawsuit. Her participation of being part of the opposition to this lawsuit for over 20 years, has delayed the awards for the beneficiaries who sued the State of Hawaii to receive their mandated homestead awards in an efficient and timely manner. This delay had prolonged the damages judgment by the Supreme Court to the plaintiffs and resulted in over 1,000 plaintiffs dying before seeing their action and perseverance being awarded in their favor. We cannot feel that, after all these years, her attitudes and thoughts can be unbiased on her part if this current administration is executing her duties as a line administrator of the HHA of 1920. I told you that it is personal to us because if you review the plaintiffs in the case, my wife Doreen is listed as such.

Second, it is our understanding that she was the DHHL Attorney General for Mr. Bill Aila in 2021 when they advocated to changing the HHA of 1920 to extend leases for current non-native beneficiaries for forty more years which would allow the Big Island's managers for the Prince Kuhio Mall for the length of 99 years, if we are not mistaken. That puts the Delaware Company lessees of the Prince Kuhio Mall on par with a lessee! AOLE! They will have had the mall for 65 years of the original lease and they have made their return on investment for many years. It is time for DHHL and beneficiaries to have their lands returned to them and let the Native Hawaiian Community decide the new future for the mall. It belongs to the beneficiaries who have been denied the use of this prime commercial site for all these years.

Third, Chair Kali Watson is a lawyer, and has access to lawyers in the department so we do not feel that a lawyer in the administrative position as a Deputy Chair is as important as a person with a financial or a construction background that can help him focus on developing the residential lots mandated by Act 279 with it's 600 million dollar spending deadline hovering over the Department. If that is the case however, we would like Governor's Green to consider Ms. Nicole Lehua Kimilau-Cano for this position. Watching her testify on behalf of the NAHASDA funds and other matters relating to DHHL policy and action, she carries herself in a professional and courteous manner when addressing the Senate. We understand that she is also a lawyer, but with many years of knowledge dealing with building, construction, infrastructure, and other matters relating to planning and development. We have had meetings with her in the past, interacted with her and consider her to be credible and able to assume the position of the Deputy Chair, if a lawyer is needed in this position. We also understand that she applied for the position, but the vetting committee never chose to interview her. Auwe. Fourth, We have attended a number of in-person beneficiary and televised meetings over the years. Only after watching the HWN Senate meetings on February 10th and 19th of this year, did we see what Kaktie Ducatt looked like, let alone met. Until that day, we did not know she was a staffer at DHHL let alone interact with homesteaders and beneficiaries except in an adversarial position.

On a side note, If there is any situation that Mr. Kali Watson cannot perform his duties as the Chair for the Hawaiian Homes Commission, she becomes the acting chair and assumes the position as chair. Does she continue to the end of his term, does she need to be reconfirmed to the Chair, or is the process starting all over again.? All we know is that any delays can be fatal to carrying out Act 279 and we feel that she will not be a strong supporter for Mr. Watson to execute this legislative Mandate.

We apologize for the length of time to explain our position as to why we are opposing her. Again, many things our opinion is based on can be hearsay and second hand notice. But we met with and talked with Ikaika Anderson, Makai Freitas, and Kali Watson. We appreciated them taking some of their time to visit with us on the outer islands and engage with us. She could have done the same outreach as they did, so it seems that we are just not important enough to meet and talk with us, even on Zoom. Our personal thoughts anyway.
