#### Dear Chair San Buenaventura:

As First Deputy, my responsibility to the Department of Health is not only to my own administration, which houses the District Health Offices of Maui, Kaua'i and Hawai'i Island, the Administrative Services Office, the Health Information Systems Office, the Office of Planning, Policy and Program Development, the Human Resources Office and the Office of Health Status Monitoring, but runs across the department with administrative support.

#### (1) Experience:

I come to the Department of Health after time spent with the Kaiser Permanente, the House Finance Committee, the Department of Human Services, the University of Hawaii at Hilo, and as an entrepreneur.

#### (2) Strengths:

I am the first First Deputy in many years from outside. This fresh perspective, and my questioning of basic processes and reasoning that long timers can no longer see, helps break the inertia common in government. Seeing this, the staff is also able to view operations through my own new eyes, and the gems of ideas generated from them are inspiring.

I use my strong administrative experience in operations, budgeting, and metrics every day in this position. My entrepreneurial experience, where I wore many hats at once, certainly helps me juggle the demands of this position.

My wholistic approach, where I see everything as being connected, ties in the often isolated offices and staff, creating a synergy that helps staff understand our whole is much richer than the sum of our parts.

To make institutional change, to manage people well, there cannot be a fear of conflict; not everyone will want the change you bring. It is in my approach, I believe, that helps bring change; by being firm and fair, I can make movement. In meeting with direct reports to communicate my expectations, several have said that in their more than dozen years, or longer, in the department it was the first such conversation with their Deputy.

#### Weaknesses:

I don't always pace myself. My personal expectations are high, and there are things I want to accomplish in my time at DOH. The day to day demands of this position easily crowd out the ability to work on the long-term changes I want to set in place. I am not always great asking for help. I recognize this and am currently looking for that help.

I commute for this job from my home on Hawai'i Island, which carries a personal cost. In this I must also temper my pace.

#### (3) Department strengths:

There is a general commitment among staff that is uncommon. I am told it is the nature of public health, which attracts a more value driven worker. The ready willingness to help, directed both outside the department and within, is cited by staff as a strength, especially in crisis situations, and I believe them. Whether frontline or management, the public health staff keep the walls of the department standing as leadership changes and crisis come and go.

Subject matter expertise is strong. The programs and offices are knowledgeable and well versed in general about their subject areas, to the point where my administration hopes to create an internal library that can be easily accessed when issues come up.

DOH has a strong regulatory mindset with clear expectations. Funded in large part with federal funds, which come with strict guidelines and reporting requirements, staff is conscious and diligent about regulatory compliance.

#### Department weaknesses:

The infrastructure is weak from years of underfunding. Systems are outdated and fragile, with frequent breakdowns that compromise getting the work done.

Weak and outdated systems translate into an absence of meaningful metrics by which to manage. DOH is missing robust, current, updated data systems that tie us in to each other.

Physical plant is old and poorly maintained, compromising safety and health. Kina'u Hale should be razed. There are no current plans to relocate the offices in the building and rebuild.

Outdated processes hamper efficiency. Redundancy in paperwork, old manual systems, and inconsistent applications tie us up and are frustrating to staff. We are currently going through these processes to simplify and update, and, where possible use technology, to streamline.

#### (4) Vision for the DOH:

That all Hawaii residents have a fair and just opportunity to a achieve optimal health and wellbeing. We will be developing benchmarks in the coming months to measure outcomes and progress.

I also include here my goals for my administration;

To create and enable a healthy environment for my staff, where they feel heard, valued, given the tools they need to be successful in their work, and to grow in themselves and their position.

To improve the systems and processes in our daily work so we can accomplish the big picture, which is,

To deliver services to the community as we are meant to, fully, with compassion and competence.

#### (5) Top budgetary priority for the biennium:

To strengthen our public health infrastructure on Oahu and the neighbor island District Health Offices; to address growing critical mental health needs for children and adults, resourcing our State Hospital; to protect our drinking water through CIP state match for water treatment and testing.

#### (6) Staff morale:

In this post COVID period, DOH staff are in the recovery phase. The attention of the past administration was outwardly focused on COVID and less towards the operations of the department. Staff voices were not always heard, some offices more isolated from the whole than others. Bringing these offices and staff back into a feeling of inclusion and trust is a priority for me.

Additionally, staff cuts have been demoralizing to those left doing the work of 2 or 3. Staff want to perform well, people want to do the right thing, but the steady erosion of positions demonstrate a counter narrative to the belief in the importance of public health. Everyone wants the vacancies filled so we can fully deliver on the services we are charged with providing, which cannot happen with inadequate staff and position counts.

The Department of Health does not collect data on staff turnover.

#### (7) Conflicts of interest:

I do not hold a second job, no longer own a business or was ever in partnership with anyone. I can foresee no conflicts.

#### Comments:

My name is Tehani Rawlins.

I have been working at the Department of Health for over 15 years; 13 of those years have been with the Office of Health Status Monitoring (OHSM), better known as vital records, in the Issuance Office and currently as the supervisor of the Marriage & Civil Union License Office.

On February 24, 2023 I was called into a meeting with the Issuance Office supervisor, Acting OHSM Chief Jean Luka, and Deputy Director Susan Fernandez. During this meeting I was:

- Accused of fraud and abuse of overtime
- Reprimanded for training new Issuance staff on how to determine legal entitlement
- Reprimanded for vetting the backlog of mail in orders spanning the period of October 2022 December 2022.
- Intimidated when I attempted to speak and offer clarification I was cut off and told "You may not respect me, but you will respect my position" with a finger pointed at me. Intimidated again, when given an ultimatum that if I didn't like it here, I could leave.
- Belittled and humiliated when myself and the Issuance Office supervisor were made to repeat "I will not do mail orders" before we were able to be excused from the meeting.

After being excused from the meeting, the Issuance Office supervisor & I went to the basement vault to talk as we were both in shock. A few minutes later, Jean Luka and Susan Fernandez were knocking on the basement vault door and Susan Fernandez asked if we were working down here. I replied no that we were decompressing after the troubling interaction we just had. Both continued to stand in the narrow doorway and ask questions. I became increasingly uncomfortable in the environment; stated such and my need to remove myself from the environment. Neither Jean Luka or Susan Fernandez moved aside so I could more easily exit the basement vault; so, I had to uncomfortably squeeze past them and wait outside the vault door area till we were again dismissed. I have never been more uncomfortable in the workplace. My heart was racing, and I was overcome with dizziness. I feared for my health and safety, notified my employer, and immediately left the office.

Since that date I have been under medical care for work related stress and anxiety. I have difficulty sleeping, stomach pains, tension in my body, and other physical symptoms when I am at work and when I am at home thinking about work or the upcoming work week. I do not enjoy coming to work. I find this even more troubling because at a OHSM staff meeting with Susan

Fernandez on 2/23/2023 she stated that one of her three main goals as the Deputy Director was to ensure that employees feel comfortable and safe in the workplace. I do not feel comfortable or safe at work because of this incident and why I oppose this measure.
