Chair Rhoads, Vice Chair Gabbard, and members of the Senate Committee on Judiciary:

I respectfully ask for your favorable consideration of Governor's Message No. 608, the appointment of Michelle Drewyer as a Circuit Court Judge of the Second Circuit Court of the State of Hawaii.

Since 2005, Michelle has served as a per diem judge both in the District Court and in Family Court. In these roles, Judge Drewyer has handled a number of issues including traffic cases, misdemeanor crimes, and civil cases like landlord-tenant disputes, as well as cases involving child custody, divorces, and child welfare.

Judge Drewyer started her career as a Deputy Prosecuting Attorney on Maui in 1991 and then served as a Deputy Public Defender for the State from 1996 to 1998. She then began a career in private practice as an associate with the law firm Ranken, Drewyer and Ranken in 1999, eventually working her way to become a Partner in 2002. Since 2013, Judge Drewyer has continued to practice criminal and civil litigation at her own law firm on Maui.

I am confident that Judge Drewyer's experience across the District, Family, Circuit, and Federal Court systems while practicing both criminal and civil law, as well as her time as a per diem judge, make her an excellent selection to preside over cases of the Second Circuit Court.

Dear Honorable Members of the Judiciary Committee,

I write in support of the appointment of Judge Michelle Drewyer to the Circuit Court of the Second Circuit, State of Hawai'i. As a deputy prosecutor, I previously appeared in front of Judge Drewyer a number of times. I have always found her to be fair, to rule justly, and to be consistent in her temperament.

I am now in private civil practice, primarily representing community organizations in land use and permitting matters before agencies and in related litigation. In that capacity, since 2019, I have represented Nā Hīnano O 'Ōpana ("Nā Hīnano"), a domestic nonprofit. Nā Hīnano is focused on promoting and preserving the agricultural character of the 'Ōpana ahupua'a. Nā Hīnano has a board of directors made up five directors. In her personal capacity, Judge Drewyer is president of the organization. I provide this testimony to provide context for any opposition that may arise from Maria Abrams or her attorney related to Nā Hīnano and ongoing community issues with the Abrams parcel.

In early 2021, Nā Hīnano petitioned to intervene in a special use permit application proceeding submitted by Lew and Maria Abrams on behalf of Sacred Earth Assembly for operation of a church on their agricultural parcel. The petition arose out of the experiences of those living in the surrounding community who had for over a decade already been bearing the brunt of the Abrams non-agricultural use of the Abrams parcel. Through the auspices of Sacred Earth Assembly, the Abrams had been operating, as one neighbor stated to the Land Use Commission "social events and activities at scale with impunity."

### The same neighbor wrote:

The community and I have lost the tranquility of our neighborhood. The noise pollution is continuous. It is the result of private cars running up/down a gravel road. The main access road to the property parcel for the SUP1 is parallel to my properties. Dogs are barking for every car passing. The gulch surrounding our properties is a natural amplifier, and it carries entertainment noises, and amplified music sounds further out. I

have also installed a gate to prevent any involuntary trespassing once and for all. As a show of solidarity for the applicants' effort with the community and his farming activities, I never filed an official complaint.

Jerome Labat to Land Use Commission, Dated October 19, 2019.

There have been concerts and other parties that have been advertised online with ticket sales. These activities are not permitted. The agricultural building in which they are held does not have a certificate of occupancy. The Abrams have also been found in violation for other structures on the property. Issuance of the permit would likely increase such activities and Nā Hīnano sought to ensure appropriate conditions on any permit issued as well as address legal issues with the permitting process.

The Abrams have a flag lot. Judge Drewyer is the nearest neighbor. She shares a common driveway with the Abrams, also relied upon by others, that is impacted by the hundreds of cars that appear for events. This driveway was never meant for the traffic it generates and it is not in an area zoned for such use. It has created a safety risk for those travelling along Hana Highway, those who turn in and out of the driveway, and those who live on Manawai, the next street down. There have been numerous accidents in this area.

Judge Drewyer has filed Requests for Service with County to address some of the issues. The Maui Planning Department's Zoning Enforcement Division, has a practice of closing requests if the land owner refuses to allow access to the property for investigation. Despite seeking assistance from the County multiple times, many issues were not addressed because the requests were simply closed.

The Abrams and their attorney have been incredibly hostile with Judge Drewyer over the past decade. Judge Drewyer has been repeatedly publicly attacked by the Abram's attorney in agency proceedings to the extent that the Abrams' attorney was asked repeatedly in a proceeding before the Land Use Commission to act civilly. This is consistent with the fears other neighbors have expressed to me of retaliation and bullying if they were to oppose the Abrams activities or filed complaints. That is one reason why the community decided to form an organization to raise their concerns collectively.

I encourage this Committee to keep this context in mind should any opposition to Judge Drewyer's appointment arise from the Abrams or their attorney, Mr. Iczkowtiz.

In my opinion, Ms. Drewyer would make an excellent Circuit Court Judge. Ms. Drewyer's legal ability, reasoning, knowledge, and interpretation are extraordinary. Ms. Drewyer has also continually and unwaveringly practiced law in a manner consistent with the highest ethical standards, and maintained those ethical standards while presiding as a per diem judge. Ms. Drewyer's patience, empathy for others, even-temper, and superior ability to keep things in perspective will all work together to give her an admirable and extremely desirable judicial temperament. She has served as court appointed counsel when requested and has accepted cases pro bono. Earlier in her career, she has also served as a Deputy Public Defender and a Deputy Prosecuting Attorney.
