My name is Nadine Y. Ando, and I am the Director for the Department of Commerce and Consumer Affairs (Department). The Department supports the appointment of Mr. Howard Lau to the Board of Professional Engineers, Architects, Surveyors, and Landscape Architects (Board) as a structural engineer member from O'ahu.

Mr. Lau has been licensed as a structural engineer since July 13, 1978, and his license is current, valid, and in good standing. During the course of his career, he has served in various leadership capacities for structural and civil engineering associations at both the local and national level. Mr. Lau has also shared his expertise to keep the community safe by volunteering with the Hawaii Hurricane Relief Fund Advisory Board,
