My vision for service on the PPB is to help the state and the city & counties deliver high quality goods and services in a timely and cost-effective manner, while ensuring fair and ethical procurement practices. I know some tasks before the PPB will be tough in this endeavor. But I hope to review procurement information presented objectively and impartially in deliberations. Hopefully, my alternative dispute resolution experience may be of some help in this effort. In short, I hope to be conscientious, transparent, fair and respectful in any task before the PPB.

In closing, I would like to thank this Committee for giving me the opportunity to be here today. Thank you for considering my nomination. I would also like to thank all those who took the time to submit testimony on my behalf and those appearing in person.
