Bill No. and Title: House Bill No. 100 - Relating to Criminal Justice Data Sharing

**Purpose:** Establishes a criminal justice data sharing working group to make recommendations for a statewide criminal justice data repository.

## The Criminal Justice Research Institute respectfully submits the following comments on HB 100:

HB 100 seeks to establish a data working group to create a centralized repository of information to improve data sharing across criminal justice agencies. The Criminal Justice Research Institute is tasked with creating a centralized statewide pretrial database and reporting system that has kept us engaged with several agencies to assess the data landscape of the state's criminal justice system. As such, we are familiar with many of the information systems criminal justice agencies use and the barriers to sharing this information and using it for research. As acknowledged in HB 100, there is no centralized repository of information. To some extent, this may be appropriate because of the operational nature of these systems, in which case it may be appropriate for certain information to be kept confidential or separate from other agency users. However, this disconnect results in barriers for better information sharing and for research purposes. To overcome these barriers, it would require a cooperative effort among multiple agencies to balance information and research goals with operational goals.

The Criminal Justice Research Institute met with the Honolulu Prosecutor's office to ensure that our work is not duplicative, and it is our understanding that this initiative would be a separate endeavor to improve information sharing. More centralized information could improve the ability for researchers to analyze criminal justice data, but we defer to the agencies involved and the Legislature to establish these priorities within the operational and resource constraints that currently exist. We are committed to collaborating on efforts designed to improve criminal justice data, and will share our work in this area to support any initiatives like this should they move forward.

Chair Tarnas and Members of the Committee:

The Department of the Attorney General (Department) offers the following comments.

The purpose of this bill is to establish a criminal justice data-sharing working group to make recommendations for a statewide criminal justice data repository.

Pursuant to chapter 846, Hawaii Revised Statutes, the Hawaii Criminal Justice Data Center (Data Center) of the Department is statutorily responsible for collecting, storing, and disseminating adult criminal history in the State of Hawaii. Each state and county criminal justice agency is required to submit pertinent criminal justice data to the Data Center's Criminal Justice Information System via direct data entry or interfaces to their records/case management systems. The pertinent criminal justice data includes, but is not limited to, arrest, prosecution, adjudication, probation, parole, and custody information. The Department believes that the Criminal Justice Information System may be expanded to include additional information as recommended on page 5, line 14, through page 12, line 2, under section 2(h) of this bill and does not recommend the creation of a new repository.

The Department believes in the importance of data sharing among criminal justice agencies and currently participates in committees and groups, including the Hawaii Integrated Justice Information Sharing (HIJIS) executive committee, whose

goals are to find solutions to allow the sharing of data securely and efficiently to improve public safety and homeland security while respecting citizens' privacy.

The HIJIS program is designed to build real-time criminal justice information sharing throughout the State to achieve greater efficiency, security, accuracy, and completeness of data sharing, reduce duplicate data entry, and speed up the processing and access to justice information. The HIJIS is governed by the HIJIS executive committee comprised of agency executives and leaders, including the majority of the agencies listed in section 2(b), page 3, line 4, through page 4, line 8. The Attorney General is the chairperson of the HIJIS executive committee.

The HIJIS program has an established agreement between partnering agencies through an executed memorandum of agreement as recommended in section 2(a)(1), page 2, lines 10-13. Operational and policy drivers are laid out in the HIJIS Strategic Plan and Tactical Plan as recommended in section 2(a)(2), page 2, lines 14-16. The Tactical Plan is revisited annually to assess priorities for the planning and development of the HIJIS program. The HIJIS program mandates privacy policies for partnering agencies and user access to safeguard information. The HIJIS executive committee meetings target data collection and sharing concerns and promote discussion on current issues and possible solutions as recommended in section 2(a)(3), page 2, lines 17-19.

The HIJIS query currently allows authorized users to request criminal history, bench warrant, and statewide firearm information in a single search. In order to reduce duplicate data entry, booking data from arresting agencies is being electronically shared with prosecutors, Judiciary, intake service centers, and correctional facilities. And for a decade, the HIJIS subscription/notification service has been working to alert supervision agencies when any pertinent persons are rearrested. The HIJIS program is working to develop capabilities to share (1) police department incident information via the query, (2) prosecutor information via the query, and (3) disposition data from the prosecutors to criminal justice agencies.

The Department is eager to continue its efforts to improve criminal justice data collection and information sharing amongst state and county agencies. The Department

recommends expanding the HIJIS program and its resources with the added support of the Legislature to emphasize the importance of data sharing and its impact on the criminal justice community. The Department also recommends an expansion of the HIJIS executive committee instead of creating a separate working group to continue finding solutions for data sharing. In addition, the Department fully supports a report being submitted to the Legislature detailing efforts by each agency to share data and recommend further actions to be taken. This promotes the accountability of agencies for their active participation in data-sharing initiatives.

The Department appreciates the opportunity to provide comments on this bill.

Chair Tarnas and Members of the Committee:

Good afternoon Chair Tarnas and members of the Committee, my name is Charlotte Carter-Yamauchi, and I am the Director of the Legislative Reference Bureau (Bureau). Thank you for providing the opportunity to submit written **comments** on H.B. No. 100, Relating to Criminal Justice Data Sharing.

The purpose of this City and County of Honolulu Package bill is to:

- (1) Establish a criminal justice data sharing working group to address the complexities of statewide data sharing in the criminal justice system and:
  - (A) Develop a formal memoranda of agreement to be executed by participating agencies to ensure the program's continued operation and coordinated planning and development;
  - (B) Identify operational and policy drivers that will influence development priorities for the program in the short and long term;
  - (C) Identify policy, legislative, and operational issues associated with the planning, development, and implementation of the program; and

- (D) Formulate recommendations for changes in policy, operations, and legislation to facilitate data sharing;
- (2) Authorize the working group to:
  - (A) Hold informational briefings and listening sessions to gather input from the public on issues related to criminal justice data sharing within the State; and
  - (B) Request assistance and feedback from subject matter experts, as needed, to enable the working group to carry out its work;
- (3) Require the working group to provide the Legislature:
  - (A) Periodic update reports, including recommendations for any legislative or administrative action the working group deems appropriate to address data sharing concerns or to enable the working group to carry out its work; and
  - (B) No later than twenty days prior to the convening of the Regular Session of 2026, a final report, including recommendations for further actions to be implemented over the following two years, for a program start date of July 1, 2028;
- (4) Request the Bureau to provide staff, research, and drafting assistance to the working group;
- (5) Require the working group to convene no later than August 1, 2023;
- (6) Specify the types of data that may be shared between departments; and
- (7) Establish an unspecified sunset date for the working group.

The Bureau takes no position on the merits of this measure but submits the following comments for your consideration.

As to the request of the Bureau to provide staffing and research and drafting services to the working group made in the measure, the Bureau believes that it may be of assistance for drafting proposed legislation. However, we note that the Bureau possesses no additional staff or other resources to assign to the working group. Further, the frequency and timing of the periodic reports are unspecified, which makes the projected workload unpredictable, and may interfere with our ability to provide services to the Legislature during both the interims and Regular Sessions. If the Committee still wishes to keep the Bureau involved with this measure, we recommend that it be amended to limit the Bureau's involvement to only the drafting of proposed legislation for the working group, and that the working group be required to timely submit requests for proposed legislation drafting to the Bureau by no later than October 1<sup>st</sup> of each year. If these requested amendments are made, then the Bureau believes that the services requested under the measure would be manageable, provided that the Bureau's interim workload is not adversely impacted by too many other studies or additional responsibilities, such as conducting studies, writing or finalizing other reports, drafting legislation, or any combination of these for the Legislature or for other state agencies, task forces, or working groups that may be requested or required under other legislative measures.

#### **RE: H.B. 100; RELATING TO CRIMINAL JUSTICE DATA SHARING.**

Chair Tarnas, Vice-Chair Takayama and members of the House Committee on Judiciary and Hawaiian Affairs, the Department of the Prosecuting Attorney, City and County of Honolulu ("Department"), submits the following testimony in <u>strong support</u> of H.B. 100

The purpose of this bill is to establish a criminal justice data sharing working group, to make recommendations for a statewide criminal justice data repository that provides real-time data sharing between agencies. The working group proposed under H.B. 100 would include the four county police and prosecutor departments, as well as the Judiciary, the Office of the Public Defenders, probation, prison and parole.

Currently, the various state and county agencies involved in Hawaii's criminal justice system all plan, design, procure, implement and operate their own individual databases and case tracking systems. For the most part, these databases work independently of one another, with little to no interface or means of transferring data between systems. This lack of data sharing creates inefficiencies, as staff are required to re-do data entry that was previously done by prior agencies (within the prior agency's database), some agencies utilize the same terminology with different definitions, and very little information can be merged efficiently from one system to the next.

Seeing the need for efficient, real-time data flow between agencies, the Department recently met with the Crime Justice Research Institute (CJRI), which was created by the Legislature in 2019 through Act 179. As it turns out, the data repository system that would be contemplated by the working group is completely separate and apart from the data system that CJRI is currently developing. While CJRI's system is designed to accurately aggregate and compile data for research and evaluation purposes, the working group would be designing a data system that can be utilized by various agencies within the criminal justice system–in real time—which would increase efficiency and accuracy, minimize duplication of work, and provide reliable information for

decision-making, starting from the time an officer first makes contact with an individual. In addition, the system that is ultimately created by the working group could be designed to feed directly and efficiently into the database being built by CJRI, potentially improving the quality of their data.

For all of the foregoing reasons, the Department of the Prosecuting Attorney of the City and County of Honolulu **<u>strongly supports</u>** the passage of H.B. 100. Thank you for the opportunity to testify on this matter.
