Chair Belatti, Vice Chair Takenouchi, and Members of the Committee: The Department of Law Enforcement (DLE) **supports** House Bill (HB) 1097, which updates chapter 329 of the Hawaii Revised Statutes (HRS), to incorporate amendments made to the federal Controlled Substances Act that were temporarily permitted in Hawaii by the temporary designation of several new controlled substances by PSD in 2022. Under section 329-11(d) and (e), HRS, PSD's temporary designation of new controlled substances shall be nullified if the next regular session of the State Legislature has not made the corresponding changes to state law.

Sections 329-11(d) and (e), HRS, provide that if a substance is added, deleted, or rescheduled under federal law, or by an emergency scheduling action taken by PSD, then PSD shall recommend to the Legislature to make the corresponding changes in Hawaii law. In 2022, PSD temporarily designated many new controlled substances, and those substances are listed in HB 1097.
