The Maui Hotel & Lodging Association (MHLA) is the legislative arm of the visitor industry for Maui County. We represent over 180 property and allied business members and 22,000 employees. MHLA supports House Bill 1245 HD1 SD1, which appropriates funds to the Department of Health to purchase of one advanced life support ambulance and related equipment to be based in central Maui, fund pay-related personnel costs for state-certified emergency medical services personnel, and increase the predictability and stability of available air ambulance services for all islands in the State.

Maui would benefit significantly from adding an advanced life-support ambulance, related equipment, and personnel (one emergency medical technician and one paramedic). An additional ambulance would help reduce death and disability among visitors and residents by responding promptly to 911 emergency calls. There have been multiple occasions where responding units come from outlying districts to assist the growing call volume resulting in longer response times for both the outlying area where no ambulance is available and the area of demand, which can, unfortunately, lead to poor patient outcomes.

Additionally, MHLA is very supportive of the recent amendment suggesting an additional appropriation to the Department of Health to increase the predictability and stability of available air ambulance services for all islands in the State

For the reasons stated above, MHLA supports House Bill 1245 HD1 SD1.

Comments:

I am writing today to testify in STRONG support of all bills regarding expansion of ambulance services in the neighbor islands, specifically today, Maui County.

I have worked in Maui's EMS system for 20 years, noting increased call volume, yet lack of expanded services for our residents and visitors. The last transport addition to Maui county was in 2003. The call volume has since doubled, causing increased response times and 911 calls being held for 10 plus minutes until an ambulance can become available. I have witnessed poor outcomes, including deaths, that may have been prevented with just the addition of one more ground transport unit, specifically in Central Maui, where we have only 1 transport ambulance, yet the largest local and probably aging population.

I would also like to speak as to the expanded role of air medical services via rotor (helicopter). I assist, fly and am a provider with the Maui Medevac program. It has potential to play a much larger role in the Maui EMS system if we could fund a dedicated crew. The current model takes a much needed ground crew off line to run the service when it is called upon, leaving Maui County with even less resources.

I am humbly asking that all such committee members continue to support our neighbor island and fund a Central Maui ground ambulance and also a dedicated crew for the Maui Medevac, that of recent, has provided expanded scope to the entire state in its time of aermedical transport needs.
