- 1 **Fiscal Implications:** Appropriates \$1.5 million for FY24 and FY25 central Maui ambulance.
- 2 **Department Testimony:** The Department of Health (DOH) offers comments for HB1245
- 3 Central Maui may be defined as the towns of Kahului, Wailuku, and Paia. Currently, there is 1
- 4 ambulance stationed in Kahului and 1 in Wailuku. The population of central Maui between 2010
- 5 2020 increased 9.0% from 50,215 to 54,721. Ambulance run data collected between 2017 –
- 6 2022 reveals annual transports averaged 3,900. Ambulance response times averaged 8.8 minutes.
- 7 Although the bill as written appropriates \$1.5 million for a second ambulance for Central Maui,
- 8 the FY23 price is \$1.6 million.
- 9 Although response times are relatively low, given the population is increasing, a central
- ambulance may be needed in the near future.
