# Testimony of DAWN N. S. CHANG Chairperson

### Before the House Committee on FINANCE

Friday, February 24, 2023 11:30 AM State Capitol, Conference Room 308 and Videoconference

## In consideration of HOUSE BILL 1254, HOUSE DRAFT 1 RELATING TO THE DEPARTMENT OF LAND AND NATURAL RESOURCES

House Bill 1254, House Draft 1 proposes to appropriate moneys to establish two (2) full time homelessness coordinator positions, one each for the Islands of Maui and O'ahu. The bill also proposes to establish two (2) half time (.5 FTE) positions, one each on the Islands of Kauai and Hawaii. **Department of Land and Natural Resources (Department) supports this bill.** 

The Department notes that it is supported in its statewide clean-ups by the Department's Division of Conservation and Resources Enforcement (DOCARE) and the Department of Transportation (HDOT), who holds the statewide contract for storage and debris removal. Thus, any homeless clean-up schedules are coordinated with these agencies, as well as local outreach agencies. More Homeless Coordinators could likely address the problem areas more frequently but would be dependent on both DOCARE and HDOT's contractor's availability, unless funding for specific island based contracts are included in HDOT budgets.

The Department requests that the physical location of the Coordinators on Kaua'i and Hawai'i be removed from this bill. Since it may be difficult to hire part-time people, we request flexibility with these two positions, including the ability to hire one person who would service both Kaua'i and Hawai'i.

We estimate the cost for one FTE Homeless Coordinator to be \$200,000. This includes start-up costs, including office supplies, a vehicle and other necessary equipment and personal protective gear. So, the total cost for two (2) full time and (2) part-time homeless coordinators would be \$600,000. In addition,

should the legislature wish to provide additional funding for homeless clean-ups, we estimate the cost would be \$720,000 for Maui and \$360,000 each for Hawai'i and Kaua'i, for a total of \$1.44 M. O'ahu would still be covered under HDOT's contract. Second year funding would be less, at \$164,000 per FTE, which would total \$492,000 for two (2) full time and (2) part-time homeless coordinators.

We estimate the cost for one FTE Homeless Coordinator to be \$200,000. This includes start-up costs, including office supplies, a vehicle and other necessary equipment and personal protective gear. So, the total cost for two (2) full time and (2) part-time homeless coordinators would be \$600,000. In addition, should the Legislature wish to provide additional funding for homeless clean-ups, we estimate the cost to be \$720,000 for Maui and \$360,000 each for Hawaii and Kauai, for a total of \$1.44 M. O'ahu would still be covered under HDOT's contract. Second year funding would be less, at \$164,000 per FTE.
