SUBJECT: <u>HB 1356</u> - RELATING TO MEDICAID PATIENT CARE.

Hearing: February 7, 2023, 8:45 a.m. Conference Room 329 & Videoconferencing, State Capitol

DEPARTMENT'S POSITION: The Department of Human Services (DHS) comments on this measure and defers to the Department of Health on relevant parts. DHS respectfully requests that any appropriation not replace or reduce priorities identified in the executive budget and forthcoming Governor's Messages.

PURPOSE: This bill appropriates funds to provide enhanced payments to type I adult residential care homes and developmental disabilities domiciliary homes that are caring for Medicaid patients.

DHS provides comments regarding enhanced payments for adult residential care homes (ARCHs) and Developmental Disability Domiciliary Homes (DD Dom) caring for Medicaid patients. First, we note that DHS does not set the rates nor directly reimburse Developmental Disability Domiciliary Homes. The Department of Health's Developmental Disabilities Division determines those reimbursement rates and payments. If there is an appropriation, it should be directed to the DOH program.

Second, this measure denotes enhanced payments for Adult Residential Care Homes (ARCH) – Type 1. However, ARCH -Type 1 care homes do not qualify for Medicaid Home and Community Based payments for their residents since, by definition, ARCHs do not provide the level of care for professional health services provided in an intermediate care facility or skilled nursing facility. The latter is a level of care required to qualify for HCBS services. <u>Expanded</u> Adult Residential Care Homes (E-ARCH) residents <u>do</u> provide the required level of care for professional health services provided in an intermediate care facility or skilled nursing facility and, therefore, would qualify for HCBS Medicaid payments.

Act 254, Session Laws of Hawaii 2022 (Act 254), whose purpose is similar to this measure, provided for one-time pandemic payments allocated for nursing facilities, Community Care Foster Family Homes (CCFFHs), and E-ARCHs. However, Act 254 did not include Adult Residential Care Homes (ARCH) as they did not qualify for these Medicaid payments.

Finally, in general, if the Legislature is considering increased payments for DHS Medicaid HCBS community residential settings such as CCFFHs and E-ARCHs, HB 1341 – Relating to Medicaid, does address those provisions.

The Hawaii State Council on Developmental Disabilities **SUPPORTS HB1356**, which appropriates funds to provide enhanced payments to type 1 adult residential care homes and developmental disabilities domiciliary homes that are caring for Medicaid patients.

In accordance with Chapter 89 of Title 11, Administrative Rules, individuals residing in Developmental Disabilities Domiciliary homes are considered "residents" not patients. We respectful request the term be corrected within HB1356.

Currently, according to the Department of Health, Office of Health Care Assurance's website there are 40 domiciliary homes and over 500 Type 1 residential care homes in Hawai'i. Covid-19 and recent increases in inflation have hit our local care homes. These homes were a key step in Hawai'i deinstitutionalization movement and allowed individuals with intellectual/developmental disabilities who need care to live in a community-based setting.

Any financial support that can be provided to these homes helps keep our I/DD population closer and more integrated into our communities and helps to improve their quality of life.

A BILL FOR AN ACT

RELATING TO MEDICAID PATIENT CARE.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

SECTION 1. There is appropriated out of the general revenues of the State of Hawaii the sum of \$ or so much thereof as may be necessary for fiscal year 2023-2024 and the same sum or so much thereof as may be necessary for fiscal year 2024-2025 to provide enhanced payments to providers of state-licensed adult residential care homes (ARCH TYPE-1) and developmentally disabled domiciliary (DDDOM) homes that are caring for medicaid patients, to assist with COVID-related costs and lost revenues; provided that the department of human services shall obtain the maximum amount of federal matching funds available for this expenditure. The sums appropriated shall be expended by the department

of human services for the purposes of this Act.

SECTION 2. This Act shall take effect on July 1, 2023.

We submit testimony as a coalition in OPPOSITION to HB1356. We are the Presidents from Five Organizations representing nearly 85% with about 1800 members of the community caregiver industry.

We oppose the measure, because this bill only covers Type I Adult Residential Care Homes and Developmental Disability Domiciliary Homes – This bill has left out Community Care Foster Family Homes, which represents the majority of Medicaid patients as well as Expanded Adult Residential Care Homes. We fine that this bill may hurt the opportunity for all community based caregivers, such as the two types of care homes left out of this bill, from receiving a pay increase.

Moreover, we are concerned that the payment identified in this bill is ENHANCED PAYMENTS. The concern we have is that a "Enhanced Payment" is temporary. We are working together to secure a PERMANENT PAY INCREASE, not a temporary pay enhancement. This bill if passed could adversely affect all community based caregivers and care homes to receive a just and fair PERMANENT PAY INCREASE.

For the reasons provided we oppose HB1356, and ask that your committee defer this bill.

As a citizen & retired state worker, I support bills that would fairly compensate physicians and licensed home operators/providers of Medicaid clients so they may thrive in communities of this state. Rapidly increasing living costs have put a strain on all, especially the most vulnerable who need available licensed homes as opposed to placement in high costing institutions that are overwhelmed. While the demand for care home services is increasing, its supply is decreasing. I support Bills 1341, 1356, 1357 & 1367 in order to avoid the negative repercussions of this crisis.

TESTIMONY FOR PAYMENT INCREASE

My name is Jesusa Quinabo, a Registered Nurse, ILWU Local 1000 president, and a licensed care home operator in Pearl City, Hawaii. I strongly support House Bill 1341 and House Bill 1474

As a Care Home Operator, a community home based facility for the adult elderly, I would like to share an ideal life for a day in my care home.

For the past 28 years, I have woken up each morning at 6 am to attend to the needs of my 5 Dementia patients with associated other disorders. I start my day encouraging my 2 residents to do their own morning routine like using the bathroom, combing their hair, brushing their teeth, and putting on their own dentures. At the same time, assisting a resident to do the same. On the other rooms, 2 residents need total care, which means, the care is dependent on the caregiver, change their soiled diapers to a clean one, get them out of bed in a wheelchair and bring them to the bathroom to assist in brushing their teeth, putting their dentures, combing their hair.

They all gather at the dining table for vital signs check and wait for 30 minutes for me to cook their breakfast.

Two patients are hand fed, with puree diet and thickened liquids. After morning medications are given, I need to monitor all of them for any medication side effects.

Activities during the day like reading, either the newspaper, the bible or a magazine, watching TV and doing a range of motion exercises for 30 minutes each, playing with the dogs and feeding the fishes excites them all.

At 10 am, each resident will take an assisted shower. This will take 2 hours.

Lunch is served at 12 noon.

At 1 pm, 3 residents play Binggo, for 2 hours, serve snacks, then take their afternoon nap.

530pm is when dinner is about to be served. Again, 2 are hand fed, and the rest need encouragement to eat their meal. Medications are given at 6pm, 8pm,and 10pm. Evening care such as brushing teeth, changing diapers, tucking them to bed is rendered as each one goes to bed at 10pm.

The above description is what I do daily on an ideal day, without incidents of going to the emergency room, doctor's appointments, picking up medications, grocery shopping, behavior management, and any call bell at night for assistance. I also attend to Phone calls from families, Case Managers, Doctors' offices, and to attend family visitors daily.

All these services I get paid for \$2.10/hr per patient. \$50.50/day, \$1515.00/day/patient.

I would like to kindly ask you to consider the merit of having a fair and biased pay. Caregivers are hard working people and doing as much needed to prosper in the caring of our elderly.
