#### RELATING TO THE STATE FOUNDATION ON CULTURE AND THE ARTS

Chair Lee and members of the Committee, the State Foundation on Culture and the Arts (SFCA), is pleased to offer testimony in **SUPPORT** of H.B.478 H.D.1. which appropriates funds for the artist fellowship program.

The State Foundation on Culture and the Arts, established in Chapter 9, Hawai'i Revised Statutes (HRS), includes responsibility for recognizing individual artists for artistic excellence through an individual artist fellowships program. As a community, it is important that we recognize and celebrate how the artistic endeavors of individuals contribute to Hawaii's rich cultural landscape and economic health of the State. Public recognition through programs such as the Individual Artist Fellowship are a reminder of the need to seek out creative solutions to our society's most complex issues.

#### **Background on SFCA Fellowships:**

From 1995 to 2008, SFCA provided fellowships in the areas of visual and performing arts. These fellowships provided for recognition and financial support for individual artists, celebrating Hawaii's creativity. In 2010, the Individual Artist Fellowship Coordinator position was abolished and the general fund budget of SFCA was reduced, eliminating the budget to recognize individual artists of Hawai'i. In 2019 the State Legislature appropriated general funds to SFCA for artist fellowships and SFCA recognized twelve teaching artists for artistic excellence and excellence in their teaching artistry.

SFCA was the recipient of American Rescue Plan Act funds through the National Endowment for the Arts in Fiscal Year 2022. A portion of the recovery funds was awarded to individual artists and cultural practitioners statewide. Awarded grantees carried out community impact projects in FY2022.

In 2022, the State Legislature appropriated \$200,000 in Coronavirus State Fiscal Recovery Relief Funds to the SFCA for artist fellowships. In response, the SFCA developed a call for cultural fellowships but put the project on hold when Governor Ige vetoed the funding. Consistent appropriation of general funds from the legislature such as H.B. 478 proposes in support of the creative arts community will benefit the State's overall economy. When we invest in our cultural economy, we invest in the economic stability of Hawai'i.

My name is Paul Janes-Brown, I am the past vice chair for Education for the Maui Democrats and past precinct president. Aloha mai kākou o Nicole Naone keia. Hello all, my name is Nicole Naone. Born and raised in Hawai'i I am an artist and filmmaker speaking exclusively for myself as an individual with comments pertaining to HB478.

I was visiting a colleague of mine at the famed Spiral Art Gallery in Omote Sando, Tokyo, Japan - when she expressed interest in coming to Hawai'i, as she had never yet been. Fastforward to us landing in Honolulu. I was excited to walk to the part of the airport which had a wall of beautiful Satoru Abe artworks. As I showed her the pieces, I explained to her that to this day one of the highlights of my career has been my inclusion in an art exhibition with Satoru Abe. I went on to talk about other Japanese artists I was excited to show her. While she nodded in acknowledgement and commented on the craftsman ship of the works - she asked me "Where are the Hawaiian artworks?".

I found myself stumped. The closest I was able to get to a "Hawaiian" artwork was a painting of ambiguously Polynesian woman by Pegge Hopper - another personal hero of mine, who is not a native Hawaiian artist.

She and I both found it interesting that I assumed a Japanese national would want to see works by Japanese artists while in Hawai'i. With all the traveling I have done throughout the continental United States and the world at large - I have never sought out Hawaiian art. I am interested in art specific to the culture I am located in. I decided to do some research into why my perception about art in Hawai'i was so incredibly different than that in any other space in the world. This brought me to looking into the Art in Public Places Collection of the Hawai'i State Foundation on Culture and the Arts.

What I learned was that it was it was first chaired by Masaru Pundy Yokouchi. And that of 2,400 artists in the collection of 7,200 pieces

- five nisei Japanese artists (Satoru Abe, Isami Doi, Bumpei Akaji and Harry Tsuchidana - made up 3% of the entire APP Collection. These five artists alone, had more pieces in the state's art collection than all of the artworks by all of the Native Hawaiian artists - combined, which as of 2020, made up approximately 2.6% of the entire collection.

Similarly, artwork by five artists of European ancestry—Shirley Russell, Juliette May Fraser, Madge Tennent, Jean Charlot, and Francis Haar accounts for approximately 3.3% of the artwork in the APP Collection. Again these five artists alone had more in the collection than all of the artworks by all of the native Hawaiian artists combined.

I am however excited to see that there are current attempts at the inclusion of Native Hawaiian artists in the SFCA. For example per the

2022 Annual Report for the State Foundation on Culture and Arts one of the the values states "We share in the responsibility to perpetuate the Native Hawaiian culture and the arts." And while it doesn't say how many or who, page four does list "increase acquisition of works of art by Native Hawaiian artists." As an accomplishment made in 2022.

Especially with nearly \$200k of the 2022 budget not being touched - I am excited and hopeful for the future of SFCA.
