Purpose of Bill:	Beginning with the 2023-2024 school year, requires the department of education and public charter schools to provide free breakfast and lunch to all enrolled students. Appropriates funds. Effective 6/30/3000. (HD1)

### **Department's Position:**

The Hawaii State Department of Education (Department) supports the intent of HB 540, HD1, but provides comments and concerns.

The school meal program operates in each Department's non-charter schools and offers meals to its students from elementary through high school. The Department has observed higher than normal negative balances across the state for School Year 2022 – 2023. As of December 2022, the balance is approximately \$100,000 statewide.

The Department understands the importance of child nutrition and its role in improving overall student health and agrees that children should have adequate meals provided to them, including lunch. It supports serving one school lunch to any requesting student at no cost each school day in every school where the students are required to eat meals at school if the Department receives funding to subsidize what is not obtained through Federal claim reimbursements.

The Department disagrees that the appropriation amount be directed to the Hawaii Child Nutrition Programs. It should be appropriated to the Department's School Food Services Branch (SFSB), which manages the school food program operations and current state funding for the Department's non-charter schools.

The cost to fund this legislation is, at minimum, \$63,840,850 at the current meal participation rates, but it ranges due to several variables we cannot account for at this time. These variables include meal participation, labor increases, and food and supply cost increases. For example, currently, lunch participation is at 50%. If participation were to increase to 75%, the need would be, at minimum, \$137,914,564. Effective July 2023, the SFSB will receive an increase in its federal reimbursement rate, at 30% above the continental United States. This rate increase was factored into these calculations, but the exact rate has not yet been verified by the Hawaii Child Nutrition Programs. Current calculations have also included additional costs to fund the Afterschool Snack Program, which although not indicated in this legislation, the SFSB participates in and receives federal reimbursement for. That represents approximately \$433,654 of the total cost to fund this legislation at the current meal participation rates.

The State Public Charter School Commission ("Commission") appreciates the opportunity to provide comments on **HB 540 HD1** which requires the department of education and public charter schools to provide free breakfast and lunch to all enrolled students beginning with the 2023-2024 school year. Appropriates funds.

The Commission deeply appreciates the support to provide free breakfast and lunch to all public school students including public charter school students. We agree that public charter school students should be provided the same as their fellow public school students in the Department public schools, however, unlike our Department public schools, not all public charter schools are participants in the National School Lunch program (NSLP). Due to operational and fiscal barriers of this federal program, many of our public charter schools do not have the personnel, nor facilities, or access to vendors that can meet the strict requirements of the NSLP. Currently only 20 of our 37 public charter schools participate in the NSLP.

Additionally, as the Commission is not structured like the Hawaii Department of Education, the Commission also does not have the capacity to manage such a program for all public charter schools. This is a fundamental difference in the way the public charter school system is structured. The Commission is more akin to a regulatory agency and not one that can duplicate the structures of the Hawaii Department of Education to support and manage such a program. We would ask that the Commission and its public charter schools be given additional time to

work with the Hawaii Department of Education and other associated agencies to find possible solutions to this problem of ensuring that all public charter schools students can be provided free breakfast and lunch.

The Obesity Prevention Task Force (OPTF), a program of Hawai'i Public Health Institute<sup>i</sup> (HIPHI), is in **strong support of HB 540 HD1**, which would provide free school meals for all students.

### **Everyone Deserves Access to an Education and Food**

Access to free public education is not given only to those who can least afford it. All students, regardless of income, are given the opportunity to attend school. The same should be true of the food served at school. Food is an absolute necessity for families and students regardless of income.

Discriminating against those whose income is just above the threshold or who have not successfully filled out the paperwork creates many adverse outcomes. Students are hungry, families miss or cannot afford lunch payments, or they must budget away from other areas of their life. Hawai'i needs to support all students, regardless of income, in receiving free meals.

### **Current Subsidies Are Not Enough**

Families with incomes above 133% of the federal poverty line require support but are not getting it.<sup>ii</sup> Families of 4 earning just \$42,000 per year are not eligible for free school meals but earn less than half of what is needed to be selfsufficient.<sup>iii</sup> These ALICE families do not qualify for free lunches despite having significant needs. 1 in 3 Hawai'i households are part of the ALICE population who need increased support.<sup>iv</sup> The arbitrary cut-off at 133% of the federal poverty line hurts children and does not accurately reflect the needs of our local families. Ending the benefits cliff is necessary to stop penalizing families earning slightly more than the maximum benefits threshold. A family with two children loses thousands of dollars in benefits simply because their income is slightly more than the allowable amount.

### **Creating a Culture for All**

The stigma that exists for students and families who participate in the free and reduced lunch program is real and can lead to increased bullying, among other negative outcomes. It is not something that should exist. Judgment should not be placed upon parents or their children due to their financial situation.

In addition, running out of lunch money happens far too often to many families. The angst that is felt by a student whose balance is low is not something that any child should experience. Freeing all of our families from the burden of maintaining a lunch fund is a benefit to all of Hawai'i. This program will support all students to feel welcomed. Students cannot be ready to learn unless their basic needs are met. Ensuring that all children are being fed helps to meet those needs.

Please pass this bill to create a Hawai'i where all students have access to school meals.

Chair Kidani and Members of the Committee:

The Hawaii State Teachers Association <u>supports HB 540, HD1</u>, relating to education. This bill, beginning with the 2023-2024 school year, requires the department of education and public charter schools to provide free breakfast and lunch to all enrolled students. Appropriates funds.

Student success demands a nourished body and mind. Too often, our children come to school hungry or without access to quality medical care, leaving them lurching through the school day, rather than learning instructional content.

In Hawai'i, food insecurity is one of the most pressing manifestations of overall socioeconomic inequality. Over 70,000 public school students eat free or reduced-price meals in our state, though only 40 percent eat school breakfasts. Hawai'i ranks 47<sup>th</sup> in school breakfast participation rates among qualifying students.

As noted in the bill, the Department of Education estimates that as many as 15,000 students each year are considered "gap" and come from gap families who do not quality for the National School Lunch Program, but struggle with food insecurity nonetheless. This bill seeks to help provide free lunches to all enrolled students, thus will prevent any child from not being able to eat lunch, or being stigmatized for not having enough funds on their account to pay for lunch as well.

Cases of chronic hunger can lead to achievement gaps, concentration loss, illness, increased absenteeism, behavioral problems, depression, and misdiagnosed learning disabilities. Thus, providing a decent meal for our impoverished children is a moral and educational imperative.

For the sake of our students' wellness, the Hawaii State Teachers Association asks your committee to <u>support</u> this bill.

The Department of the Attorney General (Department) provides the following comments.

The purposes of this bill are to require the Department of Education (DOE) and public charter schools to provide free breakfast and lunch to all enrolled students beginning with the 2023-2024 school year, and to appropriate a yet unspecified amount of funds.

In four instances, the bill mistakenly refers to "lunch" in provisions concerning school breakfasts. Because different regulations apply to school breakfast and lunches, the Department respectfully recommends that the bill be amended as follows:

- (1) Page 1, line 12: replace "lunch" with "breakfast".
- (2) Page 1, line 13: replace "lunches" with "breakfasts".
- (3) Page 3, line 9: replace "lunch" with "breakfast".
- (4) Page 3, line 10: replace "lunches" with "breakfasts".

### Testimony of the Hawai'i Appleseed Center for Law and Economic Justice Support for H.B. 540 – Relating to Education Senate Committee on Education Thursday, March 22, 2023, at 3:00PM

Aloha Chair Kidani, Vice Chair Kim, and members of the Committee:

Thank you for the opportunity to submit testimony in support (with amendments) of **H.B. 540**, which would appropriate funds to the Department of Education (HIDOE) to cover the costs of school meals for all students.

Adequate nutrition is essential for children's health, learning, and long-term development. However, there are still up to one in four children in Hawai'i that regularly go without enough nutritious meals at home.<sup>1</sup> This means that for many children in Hawai'i, school breakfast and lunch are the most nutritious meals they get in a day.

Federal eligibility for free or reduced price meals requires that households earn below 130% of the federal poverty level (\$44,850 annually for a family of four in 2023). However, Hawai'i's costs of living require that a family with two adults and two school age children make between \$70,000 and \$80,000 to survive.<sup>2</sup>

The federal government covered the full cost of all school meals during the COVID-19 pandemic, providing much needed relief for families that were struggling in an unstable economy. In prior years, school meal debt would still occasionally reach as high as \$60,000 - \$70,000 by the end of the year. However, once meal fees returned post-pandemic, the Hawai'i Department of Education (HIDOE) saw a rise in school meal debt unlike they had ever seen before, reaching approximately \$100,000 by December of 2022.

It may be prudent for the legislature to include language that would maximize the use of federal funds, thereby minimizing the costs to the state. We offer the following suggestion, which could replace the text in section 1(f) and 2(f):

## "It is the intent of the legislature that the Department of Education and participating schools use all of the federal funds, federal programs and federal provisions available in carrying out this program."

Thank you for considering this testimony in your deliberation of H.B. 540. As shown in the attached one page brief, eight states have already passed policies to fund universal free meals for students, and 22 others (Hawai'i included) are deliberating policies this year. We are pleased that the Hawai'i legislature is paying attention to this important issue at a time when it is clearly gaining momentum across the nation. Thank you for your consideration of this bill.



Thank you for the opportunity to testify in **SUPPORT** of H.B. 540 – Relating to Education, which would require the Department of Education's Hawaii Child Nutrition Program to provide free breakfast and lunch to all enrolled students beginning in the 2023-2024 school year.

## School meals are one of the government's most powerful tools for delivering good nutrition to children.

Ensuring all students have equal access to nutritious meals is one of the best ways to promote their educational and emotional development, reduce behavioral problems in the classroom, and increase positive academic outcomes in our schools. The National School Lunch Program and the School Breakfast Program are the two largest child nutrition programs and a recent study found that U.S. children receive their healthiest meals at school through these programs.

### Universal free school meals are a lifeline to Hawai'i's struggling families.

For children specifically, Hawai'i had the second highest-food insecurity rate in the nation in 2021, at about 25%. Offering universal free school meals is a lifeline to Hawai'i's struggling families that make more than the income eligibility limit, but not enough to afford school meal prices. Federal eligibility requirements dictate that only students from households earning below 130% of the federal poverty level (\$44,850 annually for a family of four in 2023) are eligible for free school meals in Hawai'i. Yet, a household survival budget for a family of four is more than \$90,000.

### A universal free school meals program is cost efficient and effective.

Implementing universal free school meals:

- Alleviates a significant financial and administration burden for school nutrition staff which allows for more time to focus on preparing and serving healthy meals to students; and
- Means that schools no longer have to collect unpaid meal fees from families and no child is denied a meal based on the ability to pay.

Forecasting a potential increase in school meal participation if universal free school meals are implemented, local advocacy organizations estimate the cost of universal free school meals to be \$20.6M annually.

**To lessen the cost of universal free school meals to the state** we encourage the Committee to amend sections 1 and 2 to include language that ensures that federal funds are leveraged as efficiently as possible. Such as: *"It is the intent of this section that the state and participating schools maximize the use of all available federal funds, federal programs and federal provisions (such as the Community Eligibility Provision) in carrying out this program."*

This bill requires the department of education and public charter schools to provide free breakfast and lunch to all enrolled students, beginning with the 2023-24 school year.

Currently, students qualify for free lunch in the National School Lunch Program (NSLP) if their families earn up to 130% of the federal poverty level (FPL) and for reduced-price lunch if their income is between 130% and 185% of the FPL.

Teri Keliipuleole Jasmine Slovak Erica Yamauchi Especially with the FPL underestimating the true extent of poverty in Hawaii,<sup>1</sup> many families that pay the full price for school meals can't make ends meet. For example, a family of four that makes \$60,000 per year doesn't qualify for free or reduced-price lunch,<sup>2</sup> while the "bare-minimum costs of basic necessities" for that same family is more than \$100,000, according to *ALICE in Hawai'i*.<sup>3</sup> If that family has two students eating breakfast and lunch at school, they must pay about \$1,300 per year for those meals.

The case for universal free school meals is strong.<sup>4</sup> Schools benefit from reduced administrative burdens because they no longer need to collect school meal applications or meal payments. Students see better academic performance and nutrition. Currently 92 DOE schools and 14 charter schools already provide universal free breakfast and lunch,<sup>5</sup> as did all schools earlier in the pandemic, thanks to federal COVID funding.

We estimate that it would cost about \$19.2 million per year to provide free breakfast and lunch to all students, if there's no increase in participation. That's based on the free, reduced-price and paid student participation in school meals in Hawai'i during the 2018-19 school year<sup>6</sup> and the current school meal prices.

We also have the highest cost of living, and many families who struggle to make ends meet pay full price for their children's meals because they do not meet federal poverty limits. Universal school meals have been linked to improved student health and academic performance, and this bill would both improve keiki nutrition and take financial pressures off of Hawai'i families. Local advocacy organizations estimate the cost of this to be \$20.6M a year – this is an extremely important investment in our keiki.

The Hawai'i Foodbank gathers donated, rescued, and purchased food and distribute it to those in need through our network of more than 200 agency partners. We are also committed to reducing child food insecurity, and we support more than 30 school pantries as well as summer and after-school feeding programs. We strongly support this bill and its effort to ensure our keiki are healthy and ready to learn.

### HOUSE BILL 540, HD1, RELATING TO EDUCATION

MARCH 22, 2023 · SENATE EDUCATION COMMITTEE · CHAIR SEN. MICHELLE N. KIDANI

**POSITION:** Support.

**RATIONALE:** The Democratic Party of Hawai'i Education Caucus <u>supports</u> HB 540, HD1, relating to education, which, beginning with the 2023-2024 school year, requires the Department of Education to provide free lunch to all enrolled students.

Hungry children can't learn.

A recent study released by the National Bureau of Economic Research focused on the federal National School Lunch Program's Community Eligibility Provision, which allows schools where many students qualified for free or reduced-price meals to provide a free meal to all students. The study examined whether the provision of schoolwide free meals through the Community Eligibility Provision impacted school suspension rates and <u>estimated that the chances of being</u> <u>suspended multiple times fell in both elementary school and in middle school.</u>

Moreover, a 2021 study by the Brookings Institute found that schoolwide free meals improve math performance. This is further bolstered by research conducted by the Food Research and Action Center, which has noted that <u>students who participate in school breakfast programs have</u> <u>improved attendance, behavior, academic performance, and achievement.</u> Studies have

clearly demonstrated the link between school meals and student success, which is especially important as schools and educators continue to strategize how to combat the loss of opportunity to learn caused by the COVID-19 pandemic.


Furthermore, providing free school meals will improve overall health outcomes, both now and in the future. Thirty million students rely on schools to provide them with breakfast and lunch every day in the United States. Those who participate in the school meal program consume breakfasts and lunches of higher nutritional quality than nonparticipants and are more likely to eat fruits and vegetables. Participation in the school breakfast program is associated with lower body mass index (BMI), lower probability of being overweight, and a lower likelihood of obesity.

More Americans are sick than they are healthy: half of adults have diabetes or prediabetes; more than half of adults have cardiovascular disease; and 3 in 4 adults are overweight or obese. Healthcare costs account for 29 percent of state budgets and 28 percent of the federal budget. As the National Education Association has stated, through universal free school meals programs, "We can grow generations of healthy eaters and save our country billions."

Notably, school meals cost less per student when more students participate in a free meal program. An article entitled in *Nutrients* entitled "Universal Free Meals Associated with Lower Meal Costs While Maintaining Nutritional Quality" found that <u>schools that participated in a</u> <u>universal meal program spent 67 and 58 cents less per lunch and breakfast</u>, respectively, while maintaining the same nutritional quality. Cost savings are especially important as many schools may face continuing budget cuts.

Nutrition is essential to academic success. This bill will ensure that Hawai'i's keiki are healthy and ready to reach their full potential.

Aloha Representative Woodson – Chair, Representative – Marten Vice Chair, and Committee Members,

The Network supports the intent of HB540 HD1 with comments. Because charter schools do not receive facilities funding, many do not have access to USDA approved kitchens. Federal reimbursements for school breakfast and lunch require the appropriate meal be cooked in an appropriate certified kitchen or the school does not qualify for food reimbursements provided by the federal government. Many of our rural charter schools do not have qualified kitchens in their communities and some DOE school cafeterias refuse to serve those charter school children.

This issue has nothing to do with the Charter School Commission and we do not need them to adopt any rules or policies.

Public Charter School students general fund per-pupil allocation and your good work to maintain the integrity of the charter school funding formula in recent years, is the only portion of resource equity public charter school students receive. Charters must transport, house, feed, and educate the children with the per-pupil provided by the legislature and are not allowed to charge tuition. The per pupil does not support the basic human needs of the child. Equity has not been achieved with regard to federal funding distribution, facilities, transportation and food. If charter schools have to pay for the meals without reimbursement it will be a huge financial hardship added to an already underfunded public educational sector of Hawaii.

Please consider amendments to HB540 HD1 to ensure successful implementation is achieved to feed our children without financially harming the economically struggling charter schools. Perhaps a provision mandating the nearest DOE approved kitchen must provide meals to the charter school in the short-term and/or in the long-term provide facilities funding so we can provide it for the children ourselves.

AlohaCare appreciates the opportunity to provide testimony in **support** of **HB540**, **HD1**. This measure, as amended, requires the Department of Education and all public charter schools to provide breakfast and lunch, free of charge, to all enrolled students beginning school year 2023-2024 and appropriates funds.

Founded in 1994 by Hawai`i's community health centers, AlohaCare is a community-rooted, non-profit health plan serving over 80,000 Medicaid and dual-eligible health plan members on all islands. Approximately half of our membership are keiki. We are Hawai`i's only health plan exclusively dedicated to serving Medicaid beneficiaries. Our mission is to serve individuals and communities in the true spirit of aloha by ensuring and advocating for access to quality health care for all. We believe that health is about supporting whole-person care.

Since the COVID-19 pandemic, food insecurity has grown exponentially negatively impacting our local families. With 1 in 6 keiki facing hunger<sup>i</sup> we need to invest in long-term solutions to support our most vulnerable populations. Providing free meals to Hawai`i's students is a step in the right direction.

Proper nutrition is vital for keiki growth and development and reduces the risk of various health conditions. This measure would ensure every student has access to healthy meals that they may otherwise be denied due to inability to pay or their household's income being even slightly over the income requirements to participate in the free or reduced lunch program. Providing meals for all students, regardless of household income, would create a sense of equality among students.

Aloha Chair Woodson, Vice Chair Marten, and Members of the Committee:

Thank you for the opportunity to submit testimony in support of HB 540 HD 1, which would appropriate funds to cover the costs of school lunches for all students in our state.

I'm Sarah "Mili" Milianta-Laffin and I teach STEM & Computer Science at Ilima Intermediate School in Ewa Beach. My school is a Title 1 school - which means we get extra money from the federal government to support our students because many of the families we serve have income at or below the poverty line. **Teachers like me unequivocally support this bill, and commend Hawai'i State Rep. Scot Matayoshi for bringing it forward.** 

Teaching during the pandemic was difficult but I never had to worry about if my students were hungry because the state was providing free breakfast and lunch for all students. As a teacher, it made me wonder why it couldn't always be like this. If you work with or have your own teenagers, you know that "hangry" (being grumpy when you're hungry) is a real thing, and I noticed less of these behaviors when students had access to free meals on campus. This year the free meal program ended, and many of my students were devastated. They had learned to count on those meals.

To qualify for "free/reduced lunch" at school families must fill out an application that basically says, "I can't afford to feed my child." These forms can be complicated and difficult for families to complete if English is not their primary language, not to mention humiliating to proud families who are doing the best they can for their kids. Hawaii families work hard to care for their children - in the nation's most expensive state to live in.

It upsets me, as a teacher and as a human, that we require parents to admit in writing that they cannot afford to feed their children, in order for children to be fed at school. There are also harmful community stories that stop families from filing out the free school lunch application forms - such as filing out these forms could get you visited by child welfare services or put potential citizenship papers at risk. While these stories are not true, the fear stops families from accessing key nutrition opportunities for their students.

To me, school breakfast and lunch are two of the most powerful learning tools out there. We have years of data that tells us that hungry students do not learn and retain information at the same level as their peers who have access to nutrition.

According to testimony submitted by the HIDOE this session, student lunch debt this year is over \$100,000. Lunch "debt" is particularly nefarious because students have no way to pay these debts on their own; they are children. Recently, a student quietly brought their friend to my classroom at lunch, and the student was visibly upset because they had picked up their lunch tray and had it taken away by a cafeteria worker because they didn't have money in their account to pay. The friend knew to bring the student to me, because I keep snacks and food in my classroom for hungry students. What does it say about us as a society if we tolerate publicly shaming kids (for something they can't control) and then leaving them hungry? This is the reason that many teachers, like myself, buy snacks for our students, taking money away from our own families (due to meager teacher salaries) to feed our students so they can learn. My husband rolls his eyes at Costco when I add food to our cart for my students, but he also knows (as teacher-husband), not to fight with me about feeding kids. You see, as the oldest of 5 children to a single mother, I was a "free lunch" kid who counted on meals at my public school to feed myself and my younger siblings. I can testify firsthand to the overwhelming benefit of free meals at school.

I also want to add that while some of my students might not have much to eat, they always share what they do have; it's the "aloha spirit" in action. I received a few boxes of chopsticks funded by a DonorsChoose grant (to encourage students not to use single-use plastics), and every lunch period kids will come pick up a few sets to share saimin bowls at lunch. Sometimes you'll see 4 students sharing 1 bowl and seeing these kids share their food always makes me mindful. In the midst of failing nutrition policy, our kids have organized themselves to provide community care and feed each other. Shouldn't the adults, leaders and policymakers learn from this example?

Please support this bill. Please visit campuses at mine during lunch times to see what it's really like for students.


