HOUSE BILL NO. 592 RELATING TO AQUACULTURE

Chairperson Quinlan, Vice Chair Hussey-Burdick and Members of the Committee:

Thank you for the opportunity to testify on House Bill 592. The bill modifies the existing plant and animal declaration form to also require in-bound travelers to the State to acknowledge state laws, federal laws, and individual responsibility to protect the environment and agriculture of the State. Requires all other documents travelers are required to complete to enter the State, except documents only relating to a dangerous communicable disease, to include an environmental and agricultural affirmation. The Department supports this bill.

The Department understands that the declaration form is often the first opportunity to impress upon visitors what it takes to protect Hawaii's unique environments, resources, agricultural industries, and overall way of life. Adding additional language to the already mandatory declaration form will bolster this. The Department suggests that additional language be added for consistency. Currently, HRS 150A-5(2)(A) allows for one adult member of a family to complete the declaration for the entire family. The Department suggests that similar language allowing one adult

member of a family to attest for their entire family be included in the proposed changes to HRS 150A-5(3) to cover all travelers entering the State.

The Department supports this measure, provided it does not impact the Department's priorities identified in the Executive Budget request. Thank you for the opportunity to testify on this measure.

Aloha Chair Quinlan, Vice Chair Hussey-Burdick, and members of the Committee on Tourism,

The Hawai'i Tourism Authority (HTA) appreciates the opportunity to offer comments on HB592, which would modify the existing declaration form for inbound travelers to ensure travelers acknowledge state laws, federal laws, and individual responsibility to protect the environment and agriculture of the State.

Hawai'i's environment is a treasure, and it is our collective kuleana to protect it for the generations to come. The intent of HB592 is in alignment with HTA's work to educate visitors about appropriate and inappropriate behaviors while in Hawai'i, including compliance with laws and local customs. The ethic of mālama – care and stewardship – is the core of those efforts.

Current avenues used to communicate these educational messages include targeted digital advertisements, videos on in-flight entertainment systems, physical signage at Hawai'i airports, and partnerships with the visitor industry to further the reach of these messages.

The existing mandatory plant and animal declaration form is an important tool used by the Department of Agriculture in their efforts to protect Hawai'i's biosecurity and defend against threats posed by invasive species. As such, we defer to DOA's position on this matter.

Should this measure be adopted, HTA stands ready to assist with implementation, including the development of language, utilizing our digital platforms like GoHawaii.com, and assisting with outreach to airlines and other visitor industry partners.
