# House Bill 630, Proposing Amendments to the Constitution of the State of Hawaii Relating to Public Education

Dear Chair Woodson, Vice Chair Marten, and Members of the Committee:

The Board of Education ("Board") respectfully provides <u>comments</u> on HB 630, which would propose a constitutional amendment that would: (1) establish local school boards throughout the State to be elected from at least 7 school districts as provided by law; and (2) create an educational standards and accountability commission.

The Board takes no position on legislation relating to the Board's membership, as the Board believes it is most appropriate for the Legislature and Governor to decide such matters. The Board will endeavor to provide the Legislature with any relevant information relating to Board membership matters to enable to the Legislature to make informed decisions.

In 2010, the Legislature passed HB 2376, which proposed an amendment to the Constitution of the State of Hawaii to change the Board from one elected by voters to one appointed by the Governor. The conference committee report on the final form of HB 2376 explained that the purpose of the bill was to "improve the accountability of Hawaii's public education system[.]" The public voted in favor of the proposed amendment that same year. Media reporting at the time linked anger over "Furlough Fridays," which some at the time claimed "could have been prevented if the [B]oard had been more directly answerable to the governor."<sup>1</sup>

HB 630 illustrates that there may be some misconceptions about what the Board and the state level of the Department of Education ("Department") do. For example, neither the Board nor the Department's state-level offices mandate "teaching approaches" to schools. The type of flexibility over "instructional programming" this bill seeks to achieve already exists in the current system. Further, the 15 complex areas create an even more localized structure for tailoring education to communities than four county-based districts would, and citizens interested in improving their local school can participate on its school community council ("SCC"), as state law requires an SCC for every single Department school.

Splitting the State's unitary statewide school district into multiple county-based school districts would undoubtedly have a number of unintended operational effects, such as needing to change the funding streams and mechanisms for public education (which could include requiring counties to pay for public education like in nearly every other state), but Board defers to the Department on operational and implementation matters related to this issue.

Thank you for this opportunity to testify on behalf of the Board.

Chair Woodson and Members of the Committee:

The Hawaii State Teachers Association <u>opposes HB 630</u>. This bill proposes a constitutional amendment that would establish local school boards throughout the State to be elected from at least 7 school districts as provided by law. It would also create an education standards and accountability commission.

This proposed constitutional amendment would add unneeded layers of bureaucracy to our educational system that would make it much more administratively top-heavy. Adding regional school boards and creating an educational standards and accountability commission runs contrary to plan objectives to streamline administrative systems with the Board of Education and the Department of Education.

The public school system in Hawai'i today accounts for a significant percentage of the state budget annually, as we are the only state in the nation that does not use property taxes to help fund our public schools. Thus, this proposed constitutional amendment would either add to that figure, or further stretch resources in the Department already competing with itself for financial resources to provide to our schools and our classrooms. We should be looking to increase the funding down to the school level and our classrooms, not making it more challenging by creating additional levels of bureaucracy.

Creating multiple districts with their own Boards would complicate that collective bargaining and further stretch resources.

### While there may be issues that need addressing to improve public education in Hawai'i, we feel strongly that this proposed constitutional amendment would not address any of them, but instead complicate them further.

The Hawaii State Teachers Association asks your committee to **oppose** this bill.

With an elected school board the distribution of power is restored between the school board, the Governor's office and the legislature.

With an appointed school board the office of the Governor now has twice the power. It absorbed the power that an elected school board once had. Now there are two parts power of the Governor to the legislature's one part power. It does not work and it never will.

Hawaii's highly centralized education system has concentrated enormous power in the hands of a relative few and they are determined to keep it. Equity in education and social justice for our schools lies in allowing our counties to have their separate and elected school boards.

To face this issue in the digital age we need only to look at data and money flow. Our student's academic proficiency has fallen year after year after year with more money coming year after year after year.

With a centralized unelected school board there is nothing to stop this slide and spending increase. It becomes harder to detail financial accountability and audit the money trail. The parents and citizens are stakeholders but remain marginalized and cut out without having a vote to choose from candidates who step forward to run for school board.

Members of the school board sit on Oahu, Despite visits to outer islands and even appointing a few outer island members, there is no chance for the local public to vote on board members who uphold ideas and excellence in education in their community. Hawaii can still uphold state standards and have local elected school boards.

Centralized education is easier for outside contractors to influence only a few decision makers who decide what all our children are exposed to. Our education system has taken a sweeping worldview 180 degree turn post covid. We have gender identity saying biology is not real and teachers, school counselors and students being trained to look at all lessons and curriculum through a lens of gender, race and oppression. Even a simple math word question needs to morph into a classroom discussion of oppression. Since when did the number 1 issue in

education become feelings and skin color? What happened to deeper thinking and real education?

Since the unions influence the Governor by being a major supporter of his campaign we need to look at the union as stakeholders. The NEA teachers union has a heavy influence on our HSTA which sends delegates to its annual conference. This year the president of the NEA cited Angela Davis as a role model teachers should follow for change. A woman jailed for bombing and other crimes. Is this the change we want in Hawaii? Teachers by the thousands were clapping at that speech. And this has been brought back to Hawaii and implemented in our centralized system without checks in balances.

Parents did not have a say in this new worldview. switch. They did not ask for soft competencies in the new transformative Social Emotional Learning. They did not ask for surveys asking their children how they feel and putting them into tier1, tier 2 and tier 3 mental health categories and keeping data on them. Who in our centralized system gave the OK to paying for all this? Now the BOE is saying their new mission and vision statement must be aligned with the global Education 2030 Agenda making our students global citizens.

This is what happens in centralized education. As Walter Heen once said, "Educational

centralization is a mountain that defies Sisyphus."

We need an elected school board in this digital age where candidates can clearly state why they are running and what they intend to do to get our proficiency turned around and develop confidence and resilience through skill building. Not constantly talking about gender and race and if kids feel sad. Common sense tells us that our children deserve so much more than that.

Why is so much in the existing system based on the concerns of the adults rather than the needs of the children? Elected school boards divided into districts will make the system student-centered rather than system-centered.

# HOUSE BILL 630, PROPOSING AMENDMENTS TO THE CONSTITUTION OF THE STATE OF HAWAII RELATING TO PUBLIC EDUCATION

# FEBRUARY 7, 2023 · HOUSE EDUCATION COMMITTEE · CHAIR REP. JUSTIN H. WOODSON

**POSITION:** Strong opposition.

**RATIONALE:** The Democratic Party of Hawai'i Education Caucus <u>opposes</u> HB 630, which proposes amendments to the Constitution of the State of Hawai'i relating to public education.

Equity is a hallmark of Hawai'i's education system. While imperfect, our state's commitment to equity in our learning system is evidenced by the weighted student formula, which distributes operational funding to public schools in manner that accounts for student need.

Moreover, Hawai'i is the only statewide school system in the nation. As such, it is funded by general funds, rather than by property taxes, unlike other school districts. Being a statewide school system heightens the need to emphasize educational equity through a state-level board of education that can guarantee fiscal balance for each complex area.

Establishing local school boards would create additional bureaucracy would undermine our state's commitment to educational equity by decentralizing school governance. <u>Hawai'i already</u> <u>incorporates local governance at the school level through school-community councils,</u> <u>which include administrators, teachers, students, and parents.</u>

Adding layers of bureaucracy to our islands' educational governance will not make our school system more efficient. Instead, it will create additional hurdles for schools to overcome in implementing federal and state policy initiatives. Furthermore, local school boards will likely lack the ability to manage and process departmental budgets in a manner that guarantees that every school within its purview receives its fair share of education revenue and support.

Let's call a spade a spade. This measure isn't being sponsored to empower schools with the capacity to respond to genuine academic concerns more effectively, like our state's chronic teacher shortage or learning loss mitigation. On the contrary, <u>this is an effort to insert an anti-intellectual and often fundamentalist agenda into our schools under the guise of "parental choice." Please do not be fooled.</u>

If enacted, this amendment would allow anti-vaxxers to challenge vaccine policies that keep our students safe and mandate curricula that run afoul of basic science, such as ideologically driven sexual health curricula. It could even precipitate attempts to undermine the legacy of Title IX by permitting conservative local school boards to adopt policies that discriminate against LGBTQ students. It would almost certainly lead to the type of "don't say gay" policies and unfounded hysteria about critical race theory that are wreaking havoc on mainland schools.

We strongly oppose this bill and the fearmongering on which it is based.

It took several months to finally CONNECT with someone on the DOE who said they could help (my daughter was not able to hear well through the masks and especially during speech therapy time. She had so many hundreds of hours of therapy on her iep but she could not progress with her pronunciation because she could not see what her tongue lips and face was supposed to do with each sound ) We finally were able to be told that the speech therapist would be given a clear mask to help with this problem. I waited several months and that never happened. I connected with her speech therapist and she said she never was contacted by Oahu's DOE and thus, a whole year of missed speech therapy opportunities really harmed her for life! I was told by our school principal that everything has to go through the DOE but then when we try to go through the DOE it just was too much bureaucracy and too far away to be accountable to help us meet our needs. This legislation is vital to helping stop the leak of the kids through the cracks so there could be accountability and faster processing times! Please approve HB630. It is the best for our keiki!!
